## **Concluding Remarks**

A bilateral approach is the best way to move forward and address the issues in the most efficient manner, particularly the legal and commercial issues in establishing single electronic window. In all these efforts, strengthening human resource capacity is crucial.

Colleagues, ladies and gentlemen,

The Program has done a lot of substantial work which could provide the basis for future actions. We have witnessed the widespread support provided by the participating countries for the current proposals to broaden the Program's trade facilitation efforts. Close cooperation, action and implementation of the following initiatives are strongly encouraged:

- i. PRC and Kazakhstan Customs' harmonization of cargo manifest and mutual recognition of customs seals
- ii. Uzbekistan's proposal for data exchange and pilot testing with Kyrgyz
- iii. Kyrgyz and Tajikistan's initiative to create a single information space
- iv. Expansion of joint customs control in the borders of Kyrgyz and Kazakhstan; and Mongolia and PRC

ADB, your Secretariat stands ready to support your initiatives and cooperation efforts. We believe that bilateral initiatives can catalyze your closer integration

into the multilateral trading system; allowing you to benefit from the advantages that this would bring.

I look forward to the participating countries' making progress on these bilateral initiatives.
