Background

What is Capacity

The ability of institutions to perform functions, solve problems and set and achieve their goals



What is Capacity Development

The process by which institution develop abilities collectively to perform functions, solve problems and set and achieve goals (effective and efficient implementation of CAREC projects)

- Implementation : 2013-2015
- Outputs development and delivery of demand driven learning program in CAREC related concerns at the strategic, policy and sector levels on a sustainable basis
- Funding available : \$1.5 million
- Funding available for energy sector : ~\$0,4 million
- Approach : Organizing Energy Sector Capacity Building Workshops
