



#### WCO Mission Statement

The WCO is an independent intergovernmental body whose mission is to enhance the efficiency and effectiveness of Member Customs administrations, thereby assisting them to contribute successfully to national development goals, particularly in the areas of <u>trade</u> facilitation, revenue collection, community protection and national security.

  - Revised Kyoto Convention (RKC) trade facilitation
  - SAFE Framework of Standards security
  - Revenue Package Revenue Collection
- Promote international cooperation



Update of Guideline



#### **Revenue Package**

- To help Members improve the efficiency and effectiveness of revenue collection, in compliance with rules, standards, and guidelines laid down in relevant international agreements, conventions and supporting tools and instruments.
- Revenue Package Action Plan
  - TA to verify the declared Customs Value
  - TA to implement and verify preferential ROO
  - Improve availability, knowledge and use of exiting tools and instruments of the Revenue Package

#### National Customs Enforcement Network (nCEN)

- nCEN is a multi-layered system comprising databases and communication tools.
  - a centralized database on seizures
  - a database on suspicious persons, companies and means of transportation and/or concealments, a company database and a picture database
  - \*a secured communication environment, exchange information (include nominal information) between nCEN to nCEN.
- Started pilot project in Mauritius from November 2010.

Expand introduction of nCEN from 2011

#### **Cooperation between ADB & WCO**

- ADB and WCO signed MOU on 4 May 2010 in Tashkent (Uzbekistan)
- Main objectives of the MOU

- Joint technical assistance and projects
- Enhance information and knowledge sharing
- Joint analytical work including publication Collaboration
- Activities
  - Preparing publishing a book on Trade Facilitation jointly
  - Workshop on Time release Study for CAREC (September 2010)
  - Trade Facilitation activities to ASEAN Customs
