### Background - Regional Plant Health Policy Dialogue (Tbilisi, March 2019)

- Under CAREC project TA 9500 (Modernizing Sanitary and Phytosanitary Measures to Facilitate Trade, a Regional Plant Health Dialogue was held in Tbilisi, Georgia 25-27 March 2019
- The primary aim was to develop a regional programme with the theme of **pest surveillance**.
- The emerging Plant Health Concept Note included the following agreed regional coordination mechanisms for 2019-21:
  - > Institutional and legislative prerequisites
    - secondary regulations to be aligned with international standards, e.g. ISPM 6 (assuming NPPO established)
    - o mentoring on Pest Risk Analysis
  - Surveillance for identified regional priority pests, using rapid test kits and pheromone traps
  - > Joint pest surveillance to provide Pest Free Areas on selected export crops
  - Development of pest surveillance guidelines and procedures manual for the CAREC region
  - Capacity building for CAREC pest surveillance staff
  - Development of a CAREC A1/A2 quarantine and regulated non-quarantine pest lists as a guide to the development of national pest lists
  - Establishment of a regional pest surveillance database/web portal for information sharing, i.e. list of major crops to be surveyed, outbreak measures, pest spread mapping, pest alerts, etc.

	1.2. Develop understanding of new EU regulations on plant health, invasive alien species and official controls	Start with GEO, AZE (EU partnership)
3. CAREC A1 and A2 pest lists	Develop common PRA management plan; regional support for national PRA team through data collection and sharing	Regional/sub-regional PRA training for identification of regional quarantine pest threats through PRA
4. Pest surveillance	Develop regional manual for pest surveillance (in cooperation with	Develop training materials such as regional guidelines for pest
