





# Speed and Reliability (Road Transport)


Average road speed (per 20-ton cargo)



Coefficient of variation of road speed



Average road and rail speed








# Speed and Reliability (Road / Rail Transport)

Average road and rail speed






Average road speed

■ Gross speed ■ Net speed










# Speed and Reliability (Road / Rail Transport)

Average road and rail speed




Coefficient variation of speed


