Rationale

- Border crossing point (BCP) is the major bottleneck - more than three quarters of waiting time and two thirds of costs incurred at the BCPs
- Complex procedures and repeated submission of same import/export information cost time and money
- Modernizing BCPs and streamlining procedures at BCPs will have the most efficiency gains



Regional Public Goods

BCP Improvement	 Benefits of BCP improvement on one side of the border cannot be fully materialized if the other side does not have similar matching investment Focus on BCPs along CAREC Corridors
SW Development	 National SWs can not achieve best results if traders and transporters have repeatedly to file declarations and manifests each time their cargo goes through a border A regional platform linking national SWs will be necessary for CAREC



Components

BCP Improvement	 infrastructure upgrades and modernization of key BCPs modern office and communication equipment, and installation of non-intrusive inspection equipment at BCPs development of trade logistics facilities adjacent to BCPs
SW Development	 Support national SW (NSW) development in selected CAREC member countries Develop a regional platform for networking of single window schemes for the CAREC region PPP approach Regional alliance of SW operators



Investment Criteria

- strong country ownership
- accession to cross-border transit agreements
- readiness of project proposal and readiness for implementation
- technical and economic viability
- positive due diligence results and results of safeguard assessments
- effective functioning of national joint transport and trade facilitation committees (NJCs)
- willingness of both sides to make complementary investments on a given BCP

- Visits to AFG BCPs are being planned
- Draft final report due 28 October
