- World Bank Logistics Performance Index

WCO Time Release Study

- Designed to measure the time required to release goods
- Tracks arrival of the goods at the port/airport/land border until their release to the importer
- Utilizes time stamps to measure elapse time for each step of the clearance process
- Identifies precisely the root causes for BCP delays
- Will be implemented by Customs
- Need CPMM partners to support Customs
 & other border authorities in study

World Bank Logistics Performance Index

- 2010 LPI just released
- Benchmarking tool to improve trade logistics performance
- Based on a worldwide survey of freight operators (with support from FIATA & GEA)
- LPI score derived from 6 components
 - √ Efficiency of clearance process
 - ✓ Quality of trade & transport Infrastructure
 - ✓ Ease of arranging competitively priced international shipments
 - ✓ Competence & quality of logistics services
 - ✓ Ability to track & trace consignments
 - √ Timeliness of meeting delivery schedule

Training for Partner Associations on Country Level Data Analysis

- Learn statistical methods used by ADB in CPMM
- Apply statistical analysis to interpret country level data
- Share results with NJC
- Use insights to support TTFS on country level

Need Good CPMM Qualitative Data

- Qualitative data will illustrate TCD data and provide deeper insights
- Good story will add color to CPMM Quarterly Report

- Highlight BCP with persistent, excessive delays
- Highlight BCP with rapidly worsening delays
- Identify BCP that needs infrastructure improvements

- Highlight BCP with consistently fast, efficient processing
- Highlight BCP with large improvement in eliminating delays
- Identify BCP where infrastructure improvements help improve cross border services

- Highlight stretches of highway with large number of check points and traps
- Highlight stretches of highway where check points and traps are increasing rapidly
- Identify stretches of highway that needs infrastructure improvements
- Identify highly congested road and highway sections

- Detail explanation on delays,
 unreasonable fees & excessive charges
- Illustrate infrastructure improvements you want to see
- Illustrate government actions you would like them to take
- Explain efficiency and service quality enhancements from removal of bottlenecks, infrastructure improvements

- Longer story can be placed in email to CPMM consultant
