- ► Government implementing agency supervised by the Minister of Finance
- Responsible for administration of customs legislation, overall on imp/exp assessment, collection of duties, compilation of trade statistics and combating Customs offences
- ► Collects 36% of the State revenues
- ► Headquartered in ULAANBAATAR, 17 customs houses with 51 border points

MONGOLIAN CUSTOMS has a:

- ▶ 9 divisions,
- Customs laboratory,
- Customs and Economic Institute,
- ▶ Detector dog centre,

- 850 Customs officers who entitled by law to examine and release goods,
- 35% between the ages25 and 35,
- ➤ 80% of the employees have higher education

CUSTOMS LAW & CUSTOMS TARIFF LAW

/Adopted in 1996

They are under revision and new version is to be introduced to the Parliament for approval this year/

Customs to share information with other agencies and Customs administrations

Systems and Procedures

- Clearance takes place at inland Customs office
- Electronic/paper combination and manual procedures of export and import system
- Controls are carried out when the goods and documents presented

- Using a e-MANIFEST /prepared by the freight forwarder and submitted to Customs/
- International and internal transit, transshipment all occur under Customs control
- Implementing automated risk management and risk assessment

Systems and Procedures

- ▶ Transfer customs process into ONE STOP service
- Reduce the clearance time
- Using of modern equipments and technology
- Expand Post Clearance Audit, improve its efficiency
- Establish permanent and relocable laboratory
- Modernize national level of HS, additions in national level

Information and Communication Technology

Mongolian Customs has developed own IT system **GAMAS** which replaced ASICUDA SYSTEM

Information and Communication Technology

- Mongolian Customs introduced own national system, GAMAS from 2002 replacing ASICUDA for newly-developed automated data interchange system for customs purpose
- ► GAMAS allows to clear goods electronically
- Network between customhouses and headquarters, compiles trade statistics
- Paperless declaration system, online payment
