

COMPLETED IN 2016, SATISFACTORY IMPLEMENTATION OF CAREC 2020

MTR recognized the need to review: i. CAREC's strategic coherence, and ii. the program's relevance.

MTR recommended to:

- i. complete the CAREC 2020 agenda;
- ii. revisit CAREC's objectives;
- iii. broaden the CAREC agenda; and
- iv. prepare a new long-term strategy for CAREC.


CAREC's Institutional Framework


- The institutional framework will need to be aligned to its new strategic framework.


KEY QUESTION 3
