With permission for Kashgar Customs, Jinlida invested 11.40 million RMB and started construction on August 18, 2006, to build a customs bonded area of over 100,00 sqm gross area with its own customs office and SPS office, composed of a warehouse of 10,000 sqm, an enclosed warehouse of 2,560 sqm and a living quarters of 1,200 sqm.

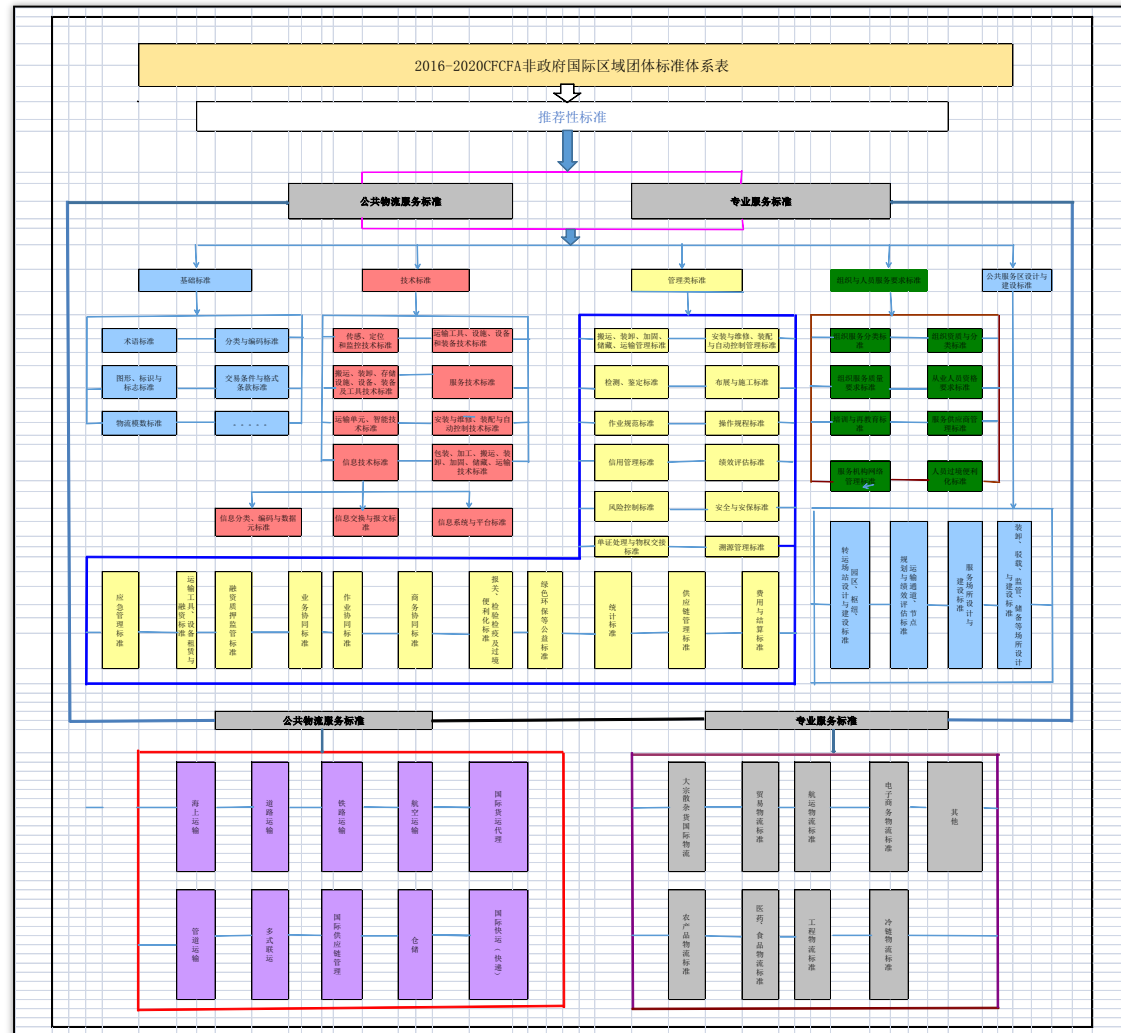
Jinlida has been applying from CFCFA membership since 2016. It actively participated in CFCFA standard development and promoted cooperation among members.
