Key Developments

1. Projects and Technical Assistance

- Regional Improvement of Border Services (RIBS) Project
 - KGZ and TAJ: PIU established and recruitment of consultants completed. NSW technical proposal being evaluated
 - MON: Project preparation on going
- Sanitary and Phytosanitary (SPS) assessment on going
 - regulatory, laboratory and border services
- PRC-MON agreed on joint customs control (JCC) expansion to two more pair of BCPs: Ceke, PRC – Shivee Khuren, MON (in March 2014) and Zhuengadabuqi, PRC – Bichigt, MON (in August 2014).
- RETA projects for customs cooperation and modernization
 - inception workshop and consultations to develop national action plans:
 - Coordinated Border Management for Results in CAREC
 - Aligning Customs Trade Facilitation Measures with Best Practices in CAREC
 - Facilitation of Regional Transit Trade in CAREC
- CPMM modified to reflect CAREC TTFS 2020 refinement
 - Expanded coverage to monitor Designated Railway Corridors
