



Challenges for traffic in transit along CAREC Corridors

Traffic in transit along CAREC Corridors is affected by a number of barriers:

- No agreements on traffic rights, thus transshipment between vehicles required
- Transit along the most direct routes not allowed by transit states, thus longer routes have to be selected
- Periodic closing of borders or temporary restrictions on transit of selected goods results in losses of trade
- No CAREC-wide customs transit guarantee system
- Cumbersome border crossing procedures results in increase of time and cost of transport in 2 times (CPMM)
- Infrastructural bottlenecks (roads and border crossing)



Freedoms of the CAREC Corridors

<u>First freedom</u>: The right to transit through foreign country without delivering or collecting cargo

Second freedom: The right to deliver cargo from country A to country B or collect cargo from country B and deliver to country A by vehicles of country A


Third freedom: The right to deliver cargo from country C to country B or collect cargo from country B and deliver to country C by vehicles of country A

Fourth freedom: The right to transport cargo within country B by vehicles of country A

Proposed CAREC approach to cross-border transport facilitation

- All CAREC countries will support first freedom of the CAREC Transport Corridors, through accession to relevant legal instruments and their implementation
- All CAREC countries will join and implement key UN conventions (TIR Convention, Harmonization Convention 1982, CMR Agreement, etc.) to enable first freedom of the CAREC Transport Corridors
- CAREC program will facilitate signing of new bilateral road transport agreements, revision and operationalization of existing agreements, based on sovereign priorities of CAREC member states



How to implement Convention on Harmonization of Frontier Control of Goods, 1982?

Convention includes recommendations on:

- Scope and procedures of border crossing controls
- Border crossing facilities and staffing of border control agencies
- Customs cooperation, Coordinated Border Management (CBM) / Joint Customs Control (JCC)
- Simplified procedures for transit and priority cargo
- Mutual recognition of weight and dimension controls
- Inspection procedures for vehicles and cargos
- Simplified driver visas
- Monitoring mechanisms
