
The CCI RT was established on March 30, 1960 and it will celebrate its 55th anniversary this year.









"Promoting the Development of the Handicraft Sector in Tajikistan Through Fair Mutually Beneficial Trade Links"

Major objective of the Project is to develop the private sector through promoting the development of market potential of small and medium enterprises in Tajikistan.

Handicraft producers and craftsmen get support through creation of favorable conditions for activities of craftsmen.

This is expressed in creation of preferences and providing assistance in organization of export of goods as well as through participation of entrepreneurs in international exhibitions and fairs as demand for organic products is extremely high in Europe.

The presentation of UMBRIA EXPORT (nongovernmental organization from Italy) on the **Project for development of handicrafts took** place in the city of Bishkek on July 31, 2014. International designers' forum "Heritage and Renaissance" was held in Dushanbe in Lotus Hotel from April 27 to April 28, 2015. This international forum ioined together enterprises handicraft private and entrepreneurs – members of the CCI RT from Dushanbe, DRS, Khatlon and Sughd regions. **Objective:** facilitating promotion of products from women handicrafts cooperatives from Tajikistan, Kyrgyzstan and Kazakhstan through improving competitiveness of products as well as rendering assistance for international markets entry by organization of exhibitions.





International Commercial Arbitration



- * Law "On International Commercial Arbitration" was adopted on March 18, 2015
- * Adoption of the Law of the RT "On International Commercial Arbitration" will promote the development of the arbitral institution in the country as one of the most important civil society institutions being an alternative way for settlement of disputes. It will also allow increasing investment attractiveness of Tajikistan and secure growth of national economy.



International Commercial Arbitration

Cooperation of the Arbitration Center and mediation of the CCI of the Russian Federation (RF) with the CCI Tajikistan started on April 2006 during the first Conference "Development of Arbitration Courts and International Commercial Arbitration in the Republic of Tajikistan" held in Tajikistan.

The second International Conference held in Dushanbe on May 2008 with participation of arbitrators from the RF was dedicated to the perspectives of arbitral proceedings in Tajikistan. The Draft Law on International Arbitration was discussed during this conference and proposals on **improvement of this project** were given.



Proposals of the CCI RT

- 1. Preferential taxation for small and medium businesses
- 2. Creation of equal conditions for all market participants
- 3. Availability of credits reduction of interest rates
- 4. Establishment of an independent body for assessment of property
- 5. Allocation of a plot of land for construction of the international exhibition center
- 6. Development of border trade through organization of joint markets within the territory of the IRA and establishment of the logistics center.



Information publications Chamber of Commerce and Industry of the RT

Since 2004, the Chamber of Commerce and Industry of the RT annually has been publishing "Business Guide" of the Republic of Tajikistan for the purpose of attraction of foreign investments. This "Business Guide" contains regulatory legal acts of the Republic of Tajikistan regulating private sector activities, needed legal framework for potential investors, lists of investment projects in priority growth areas of the economy of the RT, a list of members of the Chamber with additional information on their types of activity and contact details.
