1445 – 1545 **National Trade Facilitation Committees:** Establishment and strengthening of national trade facilitation committees has been promoted as good international practice. The United Nations Economic Commission for Europe Recommendation No.4 suggests that governments establish national trade facilitation bodies as an indispensable component of trade policy formation, which embraces the views and opinions of all stakeholders in pursuing agreement, cooperation and collaboration. In addition, the World Trade Organization's Trade Facilitation Agreement Article 23.2 mandates Member States to establish or maintain national trade facilitation bodies. Pakistan will share their National Transport and Trade Facilitation Committee experiences.
