# CENTRAL ASIA REGIONAL ECONOMIC COOPERATION PROGRAM SENIOR OFFICIALS' MEETING 27–28 June 2018; Bangkok, Thailand

#### **SUMMARY OF PROCEEDINGS**

#### I. Introduction

- 1. A Central Asia Regional Economic Cooperation (CAREC) Senior Officials' Meeting (SOM) was held in Bangkok, Thailand on 27–28 June 2018. Delegations from CAREC member countries participated along with representatives of CAREC multilateral institution partners and the CAREC Institute (CI). Mr. Ezizgeldi Annamuhammedov, Deputy Minister, Ministry of Finance and Economy of Turkmenistan chaired the SOM. Mr. Werner Liepach, Director General, Central and West Asia Department (CWRD), Asian Development Bank (ADB); Ms. Teresa Kho, Deputy Director General, East Asia Department, ADB; and Mr. Hong Wei, Deputy Director General, CWRD, ADB, co-chaired the meeting.
- 2. The objectives of the SOM were to: (i) review the progress made to date on the implementation of the CAREC 2030 strategy; (ii) discuss recent progress of CAREC operational areas; (iii) review the progress made in formulating the CAREC Integrated Trade Agenda 2030; and (iv) deliberate on the proposed structure and theme of the 17th CAREC Ministerial Conference (MC) to be held in Ashgabat, Turkmenistan. The agenda and list of participants are in Appendix 1.

# II. SOM Highlights

- 3. **Progress of Implementation of CAREC 2030.** The SOM noted the positive regional dynamics of the CAREC region marked by the revival of growth, pick up in trade, improvement in economic fundamentals and greater openness to regional cooperation which provided further momentum for the implementation of the CAREC 2030 strategy. The SOM expressed satisfaction on the overall progress in the five operational clusters since the adoption of CAREC 2030 in October 2017, including activities and ongoing scoping studies under the new sectors and areas, as well as the continuous knowledge dissemination and profile-raising activities for increased general awareness of the CAREC Program. The SOM recognized the important role of development partners in effectively advancing the expanded CAREC agenda, supported by a strengthened CAREC Secretariat.
- 4. The SOM reviewed progress in the operational clusters and discussed key issues that need to be addressed.
  - a. Macroeconomic and Financial Stability. The SOM welcomed the organization of the CAREC High-Level Forum "Macroeconomic Policies for Economic and Financial Stability" co-organized by the ADB, the International Monetary Fund (IMF), and the World Bank in Astana in May 2018. The SOM discussed the future cooperation activities proposed by the IMF in its presentation and acknowledged the importance to undertake high-level policy dialogue among CAREC member countries to improve macroeconomic policies, promote financial stability, and strengthen investment climate in the region. The SOM noted that mitigating price volatility is important for the CAREC countries, and countercyclical policy is an effective option to achieve stability during periods of economic slowdown. The SOM welcomed the recommendation of conducting annual high-level macroeconomic policy dialogue among CAREC ministries of finance, central banks, financial regulators, think tanks, and private sector practitioners. It also requested to

further deliberate on the frequency and locations of convening such dialogue taking into account busy schedule of CAREC ministers.

- b. Transport. The SOM expressed satisfaction with the implementation of the CAREC Transport and Trade Facilitation Strategy 2020 and the CAREC Transport Sector Work Plan 2017–2019, with road and railway infrastructure improvement targets set for 2020 having been surpassed. The SOM noted achievements in the areas of railways, road safety, road asset management, cross-border transport facilitation, and aviation, including (i) practical measures to implement the CAREC Railway Strategy 2030 through compilation and sharing of best commercial and operational practices; (ii) development and dissemination of three manuals on road safety engineering in advancing the CAREC Road Safety Strategy 2030; (iii) promotion of robust road asset management practices through knowledge sharing and implementation of performance-based road maintenance contracts; (iv) cross-border transport facilitation through assisting in improvement of border crossing infrastructure and implementation of the key international transport Agreements and Conventions within the entire CAREC region; and (v) dissemination of the CAREC Aviation Scoping Study findings. The SOM endorsed plans for the preparation of the CAREC Transport Strategy 2030, to be completed in 2019. The SOM reemphasized the "open and inclusive" nature of CAREC and underscored the importance of enhanced engagement with non-CAREC neighboring countries like Turkey.
- c. **Energy.** The SOM acknowledged the progress achieved by the Energy Sector Coordinating Committee (ESCC) on the key cross-border energy connectivity projects, and the efforts to move toward establishment of a common energy market in CAREC, to increase regional power supply and power trade, including off-grid solar technology and grid integration pilots. The SOM recognized the need to accelerate state-owned enterprises reform in the power utility sector to bring in private sector investment to narrow the financing gap. To this effect, the SOM welcomed the organization of the 3<sup>rd</sup> Energy Investment Forum with the theme "Financing High Technology for CAREC" to be held on 11–12 September 2018 in Batumi, Georgia, to further leverage private sector's engagement, and encouraged active participation of member countries in this important event. The SOM noted the ongoing mid-term review of the ESCC Strategy and Work plan 2016–2020 and welcomed the subsequent formulation of the CAREC Energy Strategy 2030.
- d. Trade. The SOM supported the overall framework of the CAREC Integrated Trade Agenda (CITA) 2030 and its accompanying 3-year Rolling Strategic Action Plan (RSAP) 2018–2020. The SOM also appreciated the consultative and participatory approach that was followed in their formulation. The SOM requested to further review the full draft CITA 2030, the embedded RSAP and its results framework prior to the National Focal Points' Meeting scheduled on 9–10 October 2018 to ensure ample time for internal consultations. The SOM was also apprised of the highlights of the Regional Trade Group (RTG) inaugural meeting, including the discussions on the terms of reference of the RTG, and the requirement of informing the CAREC Secretariat of the lead agency and relevant agencies for the RTG in each country. The SOM agreed that RTG will focus on over-arching trade issues. The Customs Cooperation Committee (CCC) will continue with the customs-related issues. The SOM instructed close coordination and cooperation between RTG and CCC.

The SOM appreciated the progress made on customs cooperation, implementation of the Trade Facilitation Agreement of World Trade Organization, improvement of border

crossing points and establishment of national single windows, and implementation of the CAREC Common Agenda for Modernization of Sanitary and Phytosanitary Measures for Trade (CAST). The SOM welcomed joint initiatives between Georgia and Azerbaijan on construction of joint border crossing point (BCP) and the pilot project for SPS infrastructural development on the railway BCP. The SOM endorsed the establishment of a regional SPS working group within the framework of the RTG. The SOM stressed the need to assess laboratory capacity for managing plant health, animal health and food safety. The SOM welcomed the proposed regional initiative to set up a CAREC Food Safety Network while requesting a concept paper for conducting further in-country discussions.

- 5. **Results Framework.** The SOM welcomed the work undertaken in refining the results framework to better align with the CAREC 2030 strategy and noted the progress made at the transport and trade sectors. The SOM agreed on the phased approach in the construction of the overall results framework. The SOM endorsed the proposed timeline of developing the draft transport results framework by end 2018 for CAREC members' inputs and comments, and the consolidated program results framework by 2020.
- 6. The SOM was apprised by the CAREC Institute on the implementation of the CI 2018 workplan. The SOM noted that the ongoing formulation of the CI Strategy 2018-2022 will be closely aligned with the operational clusters envisaged in the CAREC 2030, with a view to further enhancing the quality and effectiveness of the CAREC Program by providing evidence-based research, capacity building services and networking with research institutions. The SOM welcomed the organization of the Third Think Tanks Forum to be held on 17-18 July 2018 in Bishkek, the Kyrgyz Republic, and encouraged active participation from member countries.
- 7. The SOM affirmed that the 17<sup>th</sup> MC would be held in Ashgabat, Turkmenistan on 15 November 2018 with the theme along the lines of "Trade and Competitiveness in Central Asia" to deliberate on regional approaches in advancing the CAREC trade agenda, and concerted ways to strengthen trade and competitiveness as an engine of growth in CAREC member countries. The Government of Turkmenistan reaffirmed its commitment and readiness to host the 17<sup>th</sup> MC and requested high-level participation from member countries and development partners. The SOM appreciated the preparatory work conducted by the Government of Turkmenistan and instructed the sector committees and the CAREC Secretariat to expedite work to deliver the expected deliverables for the 17<sup>th</sup> MC.
- 8. The SOM expressed its appreciation to the Government of Turkmenistan, particularly the Ministry of Finance and Economy, for chairing the meeting. The SOM also expressed its gratitude to ADB for helping to organize and conduct the meeting. Recognizing the strong role of partnerships, the SOM extended its appreciation to CAREC's other multilateral development partners present in the meeting, namely, the AIIB, the European Bank for Reconstruction and Development, the International Labor Organization, the IMF, the Islamic Development Bank, the United Nations Development Programme, the World Bank, and the World Customs Organization, as well as the representatives of the CAREC Institute.
