For Endorsement by the 15th CAREC Ministerial Conference





- Formulated using a participatory approach
- Consistent with the UN
 Global Agendas
- Endorsed by the CAREC member countries in 2016
- Sets goals and targets to achieve by 2030

CAREC RSS Vision: Make CAREC corridors safe, efficient, and attractive for all road users



CAREC RSS Target: Reduce the number of fatalities on CAREC road corridors by 50% by 2030 (as compared to 2010)


