1.	Opening Remarks by CAREC Presidency and ADB (10 minutes)		
	 Mr. Ren Cong, Officer, Department of International Cooperation, National Energy Administration, People's Republic of China Mr. Joonho Hwang, Director Energy, Central and West Asia Department, ADB 		
Key messages	Mr. Cong and Mr. Hwang welcomed the CAREC member country representatives and development partners to the 32 nd ESCC Meeting.		
	Mr. Cong thanked ADB for organizing the virtual ESCC meeting. He appreciates the good efforts in advancing the energy sector which is considered a key pillar in the CAREC Program and the Central Asian region. As CAREC Chair for 2022, Mr. Cong expressed China's strong commitment to promote development and accelerate reform. He also noted that energy production has grown significantly since 2010 and explained that China developed a comprehensive value chain for renewable energy leading to significant cost reduction.		
	Mr. Hwang expressed his appreciation to Mr. Ren and the whole government of PRC for their effort to lead the program through 2022. He underscored that the goal of the 32 nd ESCC meeting was the completion of the first phase of implementing the CAREC Energy Strategy 2030. Mr. Hwang highlighted that all deliverables were achieved as planned under the ESCC Work Program 2020-2022 despite the hit of pandemic right at the start of the working period. Mr. Hwang highlighted the quality of results, thanking the tremendous effort and time of the CAREC members. Mr. Hwang also pointed out the important contribution of the previous CAREC presidencies within the last 3 years to achieve this goal. Lastly, Mr. Hwang introduced the agenda for the 32 nd ESCC Meeting.

Key messages	Working group members introduced themselves and expressed their interest in the discussion and exchange among member countries and development partners. All CAREC member countries were represented at the meeting.		



3.	ESCC Work Program 2020-2022: Achieving a major milestone in implementing the CAREC Energy Strategy 2030 (10 minutes) Ms. Sarin Abado, CAREC Energy Focal, ADB		
Key messages	Ms. Abado presented the milestones achieved by the ESCC in the last 2 years including how these contribute to the main priority areas covered in the CAREC Energy Strategy 2030. Ms. Abado also provided an indicative path to 2030 and highlighted the success of the new working arrangements in the CAREC Energy Program that contains dedicated working groups and a new web portal (www.carecenergy.org) boosting visibility of the Program and quality of results.		
4.	 Presentation of ESCC Work Program Deliverables for Endorsement (30 minutes) Concept for the new Central Asia Transmission Cooperation Association Ms. Gulnara Bakhtybaeva, Deputy Director of the Electric Power Development Department, Ministry of Energy of Kazakhstan (Chair of Work Stream 1) Launch of the Virtual CAREC Energy Reform Atlas Mr. Bakhrom Umarbekov, Deputy Director of the Project Office for The Reform of the Electricity Industry, Ministry of Energy of Uzbekistan (Chair of Work Stream 2) Concept for the CAREC Green Energy Alliance Mr. Asaf Rzayev, Head of Energy Efficiency Division of Electricity and Energy Efficiency Department, Ministry of Energy of Azerbaijan (Co-Chair of Work Stream 3) 		
Key messages	Concept for the new Central Asia Transmission Cooperation Association Ms. Gulnara Bakhtybaeva, Chair of Work Stream 1 (Infrastructure Connectivity and Energy Security) presented the main features of the proposed Central Asia Transmission Cooperation Association (CATCA) including the organization's rationale, responsibilities, organizational setup, implementation roadmap and funding options. Launch of the Virtual CAREC Energy Reform Atlas Mr. Bakhrom Umarbekov, Chair of Work Stream 2 (Policy Reform and Liberalization) presented the virtual CAREC Energy Reform Atlas (https://atlas.carecenergy.org/) which aims at providing fast responses to policy makers on all fundamental questions of energy sector reform. toolkits form part of the Atlas as foreseen in the ESCC Work Program 2020-2022: (i) Tariff Reform Toolkit, (ii) Unbundling Toolkit, and (iii) Vulnerable Consumer Toolkit. **Concept for the CAREC Green Energy Alliance** Mr. Asaf Rzayev, Co-Chair of Work Stream 3 (Energy Efficiency and Diversification of the Energy Mix) presented the main features of the proposed new CAREC Green Energy Alliance. The Alliance is designed to be the first regional financing vehicle supporting renewable & energy efficiency project. Mr. Rzayev outlined the mechanisms, the target groups and the proposed high-level structure of the Alliance. Ms. Margalita Arabidze, Deputy Head of Energy Reforms and International Relations, Ministry of Economy and Sustainable Development of Georgia, cochaired Work Stream 3 together with Mr. Rzayev. 5. **Debriefing of Recent Events (5 minutes)** Ms. Sarin Abado debriefed ESCC members on 2 recently held flagship events: (i) the Energy Key message Investment Forum (EIF) that took place in December 2021 discussing business opportunities in the field of Energy Efficiency and hosted the 2nd regional energy start-up competition; and (ii) the Women in Energy Summit that took place in March 2022 launching the 1st CAREC Women in Energy Program. 6. CAREC Energy Outlook 2030 – Presentation of Final Version (15 minutes) **Key messages** Mr. Peter Kaznacheev, Lead Consultant from the firm Roland Berger, thanked ESCC members for the comments and useful proposals received throughout the development phase of the CAREC Energy Outlook 2030 and emphasized that all remarks have been incorporated in the final version to be published later this year. The presentation covered the content of the final paper, highlighting the main trends in the regional energy markets up to 2030 which were all assessed on two levels - aggregated for region and country-specific through: (i) Supply and demand outlook, (ii) Technology outlook, (iii) Carbon emissions outlook and (iv) Investment outlook. Mr. Kaznacheev also presented the methodology used to develop the Outlook and its various scenarios. 7. Discussion (60 minutes) **Member Country interventions Development Partner interventions** ESCC members were requested to provide answers to 3 key questions with a view to closing **Key messages** the ESCC work program 2020-2022: (i) Do you endorse the virtual CAREC Energy Reform Atlas; (ii) Do you agree with the features proposed for the CAREC Green Energy Alliance and the Central Asia Transmission Cooperation Association (CATCA) and (iii) Do you accept the

CAREC Energy Outlook 2030. The following summarizes the responses given by ESCC members.

1) Do you endorse the virtual CAREC Energy Reform Atlas?

CAREC members fully endorsed the CAREC Energy Reform Atlas including its overall features, toolkits and format and appreciated its value going forward.

2) Do you agree with the features proposed for the CAREC Green Energy Alliance and the Central Asia Transmission Cooperation Association (CATCA)?

CAREC members agreed to the main features proposed for the CAREC Green Energy Alliance and similarly no objectives were voiced on the objective, role and set-up of CATCA. Tajikistan, Turkmenistan and Uzbekistan expressed that in case any further comments will arise on the CAREC Green Energy Alliance, these will be communicated soon after the meeting. *NB: No further comments were received after the meeting*.

3) Do you accept the CAREC Energy Outlook 2030.

CAREC member countries fully endorsed the CAREC Energy Outlook 2030 and appreciated the efforts that went into it and its usefulness and practicality.

Responses from Development Partners

EBRD. EBRD expressed its support of the presented reports and welcomed these initiatives being fully in line with EBRD's strategic framework, which is green, digital, and inclusive.

AIIB. AIIB expressed its gratitude to ADB and CAREC for being co-founders in regional energy projects and looks forward to doing more together in the future.

IsDB. IsDB fully supports the presented CAREC activities. It added that climate change will increasingly create water deficiencies in the region which is an area IFIs will have to draw more attention to in the future, especially when accelerating more renewable energy and hydro power projects.

CDC: CDC appreciated the efforts made in the CAREC Energy Program and highlighted that the regional shift to renewable energy will not only require adequate infrastructure for renewables but also better infrastructure for back-up fuels such as gas and especially gas transportation infrastructure. Work on issues around water shortages will also be a key issue in the years to come.

EFSD. EFSD supports the presented activities and proposed some of its regional projects to be included in the CAREC Energy Outlook and CAREC Green Energy Alliance concept note. It was agreed to take up the proposals.

UNECE. UNECE supports the CAREC energy initiatives and expressed its gratitude to be part of the ESCC meeting for the first time. It hopes to find ways to participate further particularly in the Green Energy Alliance.

UNDP. UNDP expressed its compliments on the presented initiatives, especially on the CAREC Energy Reform Atlas. UNDP appreciates the excellent toolkits that can be utilized on both national and regional levels and even in municipalities. UNDP also suggests promoting the Atlas to its stakeholders making it more widely known and utilized.

CAREC INSTITUTE. CAREC Institute agreed with the deliverables presented and expressed that it is ready to play an active role in facilitating the further implementation to the best of their capacity and research conducted on regional integration issues in energy.

USAID. USAID expressed its support to the CAREC energy initiatives and considers them attractive and promising. It was mentioned that USAID is currently supporting 3 projects under its regional mission which also enhance the CAREC Energy Agenda, these are: (i)Future Energy, (ii) Development of Regional Power Market, and (iii) Energy of Central Asia. USAID expressed its continued commitment to closely cooperate with the CAREC Energy Program in the future.

As the Chair of the CAREC Program 2022, PRC will review all reports once more before their further submission to the CAREC Senior Officials Meeting, National Focal Points Meeting and Ministerial Conference. Any further remarks by the Chair will be incorporated in the papers.
