# ZONING THE TERRITORY OF KAZAKHSTAN INTO FMD ZONES

The territory of Kazakhstan was divided into a zone free from foot-and-mouth disease and a zone with vaccination against foot-and-mouth disease (*East Kazakhstan, Almaty, Zhambyl, Turkestan and Kyzylorda regions*)

The FMD vaccination zone serves as a buffer to protect the rest of the territory of the Republic of Kazakhstan from the introduction of foot and mouth disease from disadvantaged countries (PRC, Uzbekistan, Kyrgyzstan)



# Cooperation of the Republic of Kazakhstan with PRC in the field of veterinary medicine

## Agreed animal health requirements for the import of live animals and livestock products

- Protocol between the Ministry of Agriculture of the Republic of Kazakhstan and the General Administration of Quality Supervision, Inspection and Quarantine (GAQSIQ) of the People's Republic of China on inspection, quarantine and veterinary and sanitary requirements **for frozen meat of small ruminants** exported from the Republic of Kazakhstan to the People's Republic of China (*Astana, June 8, 2017*);
- Protocol between the Ministry of Agriculture of the Republic of Kazakhstan and the GAC of the PRC on inspection, quarantine and veterinary and sanitary requirements **for beef** exported from the Republic of Kazakhstan to the PRC (*Beijing, June 7, 2018*);
- Protocol between the Ministry of Agriculture of the Republic of Kazakhstan and the GAQSIQ of the PRC on quarantine and health requirements **for equine animals** exported from Kazakhstan to the PRC (*Hangzhou, September 2, 2016*);
- Protocol between the Ministry of Agriculture of the Republic of Kazakhstan and the GAQSIQ of the PRC on inspection, quarantine and sanitary requirements **for honey** exported from Kazakhstan to the PRC (*Beijing, May 14, 2017*);
- Protocol between the Ministry of Agriculture of the Republic of Kazakhstan and the GAC of the PRC on veterinary and sanitary requirements **for dairy products** exported from the Republic of Kazakhstan to the PRC (*Beijing, September 11, 2019*);
- Protocol between the Ministry of Agriculture of the Republic of Kazakhstan and the GAC of the PRC on inspection, quarantine and veterinary and sanitary requirements **for raw woolen materials** exported from the Republic of Kazakhstan to the PRC (*Beijing, September 11, 2019*);
- Protocol between the Ministry of Agriculture of the Republic of Kazakhstan and the GAC of the PRC on inspection, quarantine and veterinary and sanitary requirements **for pork** exported from Kazakhstan to China (*Nur-Sultan, September 25, 2019*).
