RCI-OP in the Context of Future Development of the Asia-Pacific Region

Linking RCI Strategy Pillars 1 and 3 Strengthening Connectivity between economies Investing in regional **Common and Public Goods**

Linking RCI Strategy Pillars 1, 2, 3 and 4

Raising **Competitiveness** in connected markets

Linking RCI Strategy Pillars 2 and 3



Note: The RCI Strategy pillars are: Pillar 1—cross-border infrastructure and related software; Pillar 2—trade and investment cooperation and integration; Pillar 3—monetary and financial cooperation and integration; and Pillar 4—cooperation in regional public goods.

Operational Direction #1: Strengthening Connectivity between Economies

- Improving cross-border physical connectivity between the region's economies
- Enabling effective use of cross-border physical connectivity
- Helping promote regional financing for crossborder infrastructure



Operational Direction #2: Raising Competitiveness in Connected Markets

- Promoting cross-border economic corridors
- Promoting FDI promotion and facilitation corridors
- Promoting value chains, especially for SMEs
- Promoting regional capital market development
- Promoting cross-border transfer of skills and knowledge



Operational Direction #3: Investing in Regional Common and Public Goods

- Investing in cross-border public health
- Mitigating the risks and impacts of climate change, natural hazards, transboundary pollution, and the need to protect biodiversity
- Strengthening regional cooperation mechanisms



Promoting collective action: CAREC's priority sectors

Trade Facilitation

- CAREC Corridor Performance Measurement and Monitoring (CPMM)
 - Examines the efficiency of the 6 CAREC transport corridors, identifies bottlenecks, and determines course of action to address bottlenecks
 - o Carried out in cooperation with the CAREC Federation of Carrier and Forwarder Associations
- CAREC Regional Improvement of Border Services (RIBS)
 - \circ Will develop national single window with regional interoperability
 - o Coordinated initiatives by Kyrgyz Republic, Tajikistan, Mongolia, and Pakistan

Transport

- Greater Mekong Railway Association
 - Will develop institutional capacity in GMS countries and support railway connectivity and interoperability
 Established in 2013 by the 6 GMS countries
- Bangladesh-Bhutan-India-Nepal Motor Vehicles Agreement
 - Will facilitate passenger and cargo vehicular cross-border traffic to reduce cost and time of transshipment at border crossing in the 4 countries
 - \circ Agreement signed by the 4 countries in June 2015

Energy

- TAPI Natural Gas Pipeline Project
 - Will transport natural gas from Turkmenistan to Afghanistan, Pakistan and India, diversifying Turkmenistan gas exports and providing long-term energy security for buyers
 - o Investment agreement between the 4 countries signed in April 2016



Promoting collective action: CAREC's 2nd tier areas

Health

- GMS Health Security Project (proposed)
 - Will improve health of migrants and mobile population through strengthened surveillance of communicable diseases and improved diagnostics and treatment
 - o Coordinated initiatives in Cambodia, Lao PDR and Myanmar

Agriculture

- GMS Core Agriculture Support Program (CASP) Phase II Regional TA
 - Will strengthen regional policy framework and capacity for agri-food quality management, establish etrade of agri-food production of smallholders, and strengthen institutional capacity of the GMS Working Group on Agriculture
 - Implementing the GMS CASP Phase II (2011-2020)

Disaster Risk Management and Climate Change

- Strategic Program for Climate Resilience in the Pacific
 - Will integrate climate change adaptation and related disaster risk reduction into national and local development policies and plans and build Pacific DMCs' capacity to respond to climate change risks
 - Supports the Pacific Regional Strategic Program for Climate Resilience (approved in 2012) implemented through the Council of Regional Organization in the Pacific (CROP)

Finance

- Asian Bond Markets Initiative
 - Develops liquid bond markets in ASEAN+3 countries and enables better utilization of the region's savings for investments
 - Established in 2003 by ASEAN+3 countries



CAREC Institute's role in promoting collective action

- Produce knowledge products on key RCI issues in CAREC, and sectoral and thematic issues with regional significance
 - Develop pilot projects for priority sectors, exploratory work on 2nd tier areas
 - Assess CAREC's role in promoting inter-subregional cooperation given its position as a key link between Asia and Europe
- Cooperate with national research centers, other regional think tanks and educational institutions on specific RCI issues
 - The Asia-Pacific Center for Water Security was established by Tsinghua and Peking universities with ADB to focus on the region's water-food-energy security nexus issues
 - The South Asia Urban K-Hub aims to build the capacity of urban research or training institutions in South Asian countries to provide policymakers with innovative and evidencebased solutions
- Share best practices on RCI through capacity building and learning programs
 - The Urban Knowledge Hub established by ADB and Tongji University in Shanghai, PRC promotes sustainable urban development in the region through dissemination workshops and annual best practice awards
- Organize existing information for wider dissemination, such as through websites and portals
 - The GMS Environment Operations Center runs a dedicated website and online library for resources such as publications, reports, videos, and activities and events of the GMS Core Environment Program
