RIBS Project

- The KGZ Law adopted as of 12 July 2013, № 136, ratified the Agreement between the Kyrgyz Republic and the ADB on financing the Regional Improvement of Border Services Project (hereinafter – the RIBS) dated May 22, 2013
- RIBS components:
 - construction of Karamyk border crossing point
 - development of the National Single Window
- The amount of project investments is US\$9.887 million (of which: Grant – US\$4.202 million, loan – US\$4.202 million, KGZ's co-financing – US\$1.483 million)
- Closing date December 31, 2017



RIBS Project

- Executing agency the Ministry of Economic of the Kyrgyz Republic (MEoKR)
- Implementing agency State enterprise "Single Window Center" under the MEoKR (SE SWC under the MEoKR)
- To implement the RIBS, the Project Implementation Unit (PIU) is established at the SWC under the MEoKR.
- The SCS provides support in RIBS implementation.



RIBS Project

- In 2014 the Project Implementation Unit (PIU) was established at the SE SWC under the MEoKR
- October, 2015 the PIU conducted a tender for preparation of design and cost documents for construction of BCP Karamyk
- October, 2015 the PIU and OJSC "Kyrgyzgirpostroi" signed a contract on development of design and estimation documents
- October, 2015 by order № 25 of the MEoKR as of 25.10.15 the interagency commission on RIBS implementation was established (consisting of heads from the MoE, MTC, SFS, SCS, MoH, etc.). The SCS is represented by Berdaliev Sh. a deputy chair of the SCS.

Construction of BCP Karamyk

Support by the SCS:

- April, 2015 the PIU was provided with the Terms of Reference for preparation of the design and estimation documents for construction of BCP Karamyk according to the requirements of the Customs Union and the Technical Conditions for application of technical radiation and customs control equipment based on the Customs Union's standards
- October, 2015 the Technical Specifications have been provided to increase power capacity at BCP Karamyk, technical characteristics of equipment to be installed, as well as their dimensions according to the "road map"
- The SCS organized working meetings with the ADB, PIU, SCS, SFS. MTC, MoH, SIVFB and the designer.



Construction of BCP Karamyk

- By order № 150 of the MEoKR dated July 24, 2013 the tender commission was established to implement the RIBS project on construction of BCP Karamyk
- By April 9, 2016 the DEDs for construction of BCP Karamyk were prepared
- On May 20, 2016 a tender was announced to select the constructor for construction of BCP Karamyk
- Bids were opened on May 20, 2016
- On May 30, 2016 the bid evaluation report was submitted to the ADB for consideration
- On August 16, 2016 the ADB approved the evaluation report
- By end of September, 2016 the contract on construction of BCP Karamyk is expected to be signed



National Single Window Development

- Four working groups were established (on SWS support and administration, SWS legal support, business processes review, information technology)
- 152 recommendations were prepared to streamline operations of 10 agencies related to external trade
- In September 2015 the master plan and the plan for implementation of the recommendations were prepared
- 23 bylaws on external trade were drafted
- By July 2016 the model of the NSW scheme with the description of its functions was developed
- The work is on-going to draft specifications for NSW software
