- ❖ 业务流程分析法，辅以放行时间研究和时间-成本-距离法
- ❖ 主要功能
  - (1) 制定/更新促进贸易便利化的建议并给予优先考虑
  - (2) 衡量和评估贸易便利化的进展情况。强调贸易和运输便利化监测机制应与国家贸易和运输便利化委员会（或同等机构）建立稳固的基础，并依靠国家资源使之可持续和负担得起。
