Concept Note

I. Background

The Corridor Performance Measurement and Monitoring (CPMM) mechanism was developed by the Central Asia Regional Economic Program (CAREC) to evaluate a set of trade facilitation indicators (TFIs) that monitor the overall annual performance and efficiency of the CAREC corridors connecting all 11 CAREC member countries. It aims to (i) identify the causes of delay and unnecessary cost to cargo moving along the links and nodes of the CAREC corridors; (ii) help national CAREC authorities determine how to address identified bottlenecks; and (iii) assess the impact of regional cooperation initiatives implemented along the CAREC corridors by member countries. In addition to monitoring and evaluation of the efficiency of border points along the CAREC countries, CPMM data also facilitates evidence-based decision making to improve trade logistics services that creates further economic benefits for the region.

The CAREC Program initiated a review of the CPMM with a view to enhancing its effectiveness in fostering the development of the CAREC Corridors. This workshop will introduce to the CPMM stakeholders, specifically its private-sector freight forwarder association partners, the focus shifts in data collection, validation, and dissemination. It will also discuss the issues encountered during the pilot implementation of the revised CPMM methodology and how to address them.

In addition, the workshop will provide an opportunity to map out the partnership between ADB and CAREC Institute in the implementation of CPMM and efficient promotion of its outputs among the stakeholders.

II. Target Participants

This workshop will gather private-sector CPMM partners and select customs authorities to present the CPMM methodology improvements and its pilot implementation. It will also gather members of the CPMM from ADB and CAREC Institute to discuss the ongoing partnership in the implementation of CPMM.
