Senior Officials' Meeting 2nd Ministerial Conference on Central Asia Economic Cooperation

11 November 2003, Tashkent

I. Objectives

The purpose of the Senior Officials' Meeting (SOM) is to prepare for the Ministerial Meeting of the 2nd Ministerial Conference on Central Asia Economic Cooperation. Specifically, the SOM will (i) finalize the Draft Report of the Senior Officials' Meeting to the Ministerial Conference; and (ii) review draft Joint Ministerial Statement.

II. Output of the SOM

The output of the SOM will be (i) finalized Report of the Senior Officials' Meeting to the Ministerial Conference (the Draft Report); and (ii) revised draft Joint Ministerial Statement.

The Draft Report, to be prepared and circulated prior to the SOM, will be the basis for discussion at the SOM. It will have four sections. The first three sections will be drafted based on the draft outline report endorsed at the 27-28 September Regional Preparatory Meeting (RPM) as follows:

- (i) progress report: to report on how the call from the ministers at the 1st MC for actions in various areas has been addressed since March 2002;
- (ii) sector outcomes: summarizing by sector the outcome from the RPM; and
- (iii) institutional issues: addition of committee and working group; MI WG; and strengthening the OIF to meet increased needs.

In addition to the above, a possible issue for consideration of the 11 November SOM is the future participation of the Russian Federation (and related with this, the more general issue of criteria and procedures if new members are to join). This would be reflected in the Draft Report.

III. Participants and Meeting Arrangements

Senior officials of the country delegations including national focal points and representatives from line ministries and Multilateral Institutions (MIs) will participate in the SOM.

The SOM is proposed to be chaired by a representative of the Government of Uzbekistan and co-chaired by an official from the Asian Development Bank.

All sessions will be held in plenary and are closed sessions.

The chairperson/co-chair of the SOM will report the outcome of the SOM to the Ministerial Meeting the next day.
