

CAREC High-Level Session: "Financing Greener Value Chains in the Central Asia Regional Economic Cooperation (CAREC) Region"

Introduction

Global trade and supply chains continue to be associated with high carbon emissions, with an estimated 20-30% of the total CO₂ emissions according to the World Trade Organization (WTO). At the same time, global and regional trade can play an important role in tackling climate change risks. Coordinated policies, interoperability of systems and standards, and adoption of green technologies can positively contribute to countries' decarbonization efforts. Strengthening cooperation among countries is crucial to design regional smart solutions that can help increase connectivity, reduce barriers to cross-border trade for seamless movement of goods and services, and develop resilient value chains in a way that is socially and environmentally sustainable and contributes to achieving countries' climate objectives.

Objectives

This high-level seminar will reflect on the challenges and opportunities to build more resilient and greener value chains in the CAREC region. In particular, the seminar will discuss the role of regional cooperation in strengthening CAREC's linkages with global value chains while advancing the climate change agenda. Investment needs on decarbonization, upgrading of ports, trade digitalization and smart border crossing systems, renewable energy, and adaptation will be discussed. The seminar will explore opportunities to mobilize financing and support the preparation of climate projects in CAREC countries.
