
#### **CAREC ROAD SAFETY STRATEGY 2017-2030**







## ONGOING ACTIVITIES: CAREC REGION ROAD CRASH DATA REVIEW AND DEVELOP WEB BASED DASHBOARD TO REPORT ACCIDENTS

- Country reviews including of crash data management by CAREC member countries, include assessment for collection at the national level and recommendations for improvement
- Propose a standard collision classification system for the CAREC region based on systems used in best practice countries and considering CAREC region specific conditions
- Develop a web-based dashboard to report accidents through existing organizational resources available in each province.
- In-person regional training on improvement to crash data management



#### ONGOING ACTIVITIES: ROAD SAFETY CAPACITY BUILDING FOR MONGOLIA

#### Road safety capacity building for Mongolia:

- ✓ Draft regulations for road safety audits and assessments
- ✓ establish a road safety engineering function
- ✓ Conduct capacity building in road safety principles, management and practice
- ✓ Train road engineers in road safety audit, iRAP assessment and network safety rating



#### INTERACTION OF ROAD SAFETY WITH CLIMATE CHANGE

- All CAREC Countries are signatories to the Paris Agreement on climate change and have announced decarbonization targets.
- With a strengthened priority for decarbonizing road transport, all aspects of road system management are expected to take into account their impacts on future greenhouse emissions and their alignment with decarbonization pathways.
- The assignment will address three fundamental questions for the CAREC region
  - ✓ What are the climate impacts of road safety action?
  - ✓ What are the road safety impacts of climate action?
  - ✓ What are the climate impacts of death and injury in road use?
- Excel based model will be developed to calculate the impacts

- Remote and urban road safety
- Occupational road safety
- Commercial vehicle safety
- Financing mechanisms for road safety
- Implementation of national road safety action plans
- Use of ITS and digital technologies to enhance road safety
- Projects and capacity building programs on speed management, vehicle safety standards
- Road safety projects
