Third CAREC Working Group on Health Meeting

2nd of March 2023

Summary of Proceedings

I. Introduction

- 1. The third CAREC Working Group on Health (WGH) meeting was held virtually on the 2nd of March 2023, with Georgia as the CAREC chair country. CAREC WGH members, other CAREC country delegates, development partner representatives, and ADB officers and consultants were in attendance. Dr. Tamar Gabunia, First Deputy Minister of the Ministry of Internally Displaced Persons from Occupied Territories, Labor, Health and Social Affairs of Georgia, provided the opening remarks with Mr. Aziz Haydarov, Officer-in-Charge, Social Sector Division of the Central and West Asia Department of ADB.
- 2. The objectives of the meeting were to: (i) finalize and approve the CAREC Regional Investment Framework (RIF) for Health 2022–2027 and (ii) agree on the CAREC WGH arrangements and creation of the sub-working groups (SWGs). The agenda and participant list are attached as Appendix 1.

II. Meeting highlights

- 3. **Updates from the CAREC Health Secretariat.** Since the CAREC Health Strategy endorsement in November 2021, regional webinars have been conducted to strengthen health systems resilience and promote regional health cooperation. These include webinars on (i) Vaccine Hesitancy and Behaviour Change Communication, (ii) Strengthening Procurement and Supply Chain Management for possible regional collaboration, (iii) Practical Epidemiology for CAREC and Caucasus countries, (iv) Strengthening Drug Regulatory Capacity; and (v) Data standards and Interoperability as catalysts for innovation in digital health and business process documentation.
- 4. The Secretariat also reported on the 2nd meeting of the CAREC WGH held in Tbilisi, Georgia, in October 2022. The meeting enabled sharing of the CAREC Health Strategy implementation progress and further alignment of the draft RIF to country priorities and needs.
- 5. The Secretariat further shared information on the forthcoming repository of health security trainings and materials and video on innovative solutions for addressing CAREC and Caucasus health threats. The Secretariat thanked the CAREC countries for their contributions to the video content.
- 6. **Review of the Regional Investment Framework on Health.** The Secretariat provided a run-through of the proposed RIF activities for the four strategic pillars and cross-cutting themes. The Secretariat emphasized that the RIF is a living operational document guiding regional health cooperation and supporting investment coordination across countries and development partners. Its implementation will be through countries' initiatives and funding with support from development partners through regional investment projects or selected technical assistance.
- 7. All the CAREC country representatives present in the meeting fully endorsed the RIF. The countries also expressed support for the RIF implementation and reporting of achievements against the CAREC Health Results Framework.

- 8. Some countries provided updates on regional health security and cooperation activities. Azerbaijan's fully digitalized surveillance system is implemented nationwide and used to share data with WHO under the International Health Regulation (IHR) and to exchange monthly epidemiological data with Georgia for seven border districts. The Kyrgyz Republic submitted expression of interest to the Pandemic Fund for strengthening One Health approach. The country is awaiting its next joint external evaluation of IHR capacities and developing plans to enhance cross-border activities, including joint simulation exercises with border countries.
- 9. Development partners present expressed support for the RIF implementation through direct country assistance and the regional cooperation platform.
- 10. **Pandemic Financing Facility.** The Secretariat apprised the countries of the plan to submit a multi-country proposal to the Pandemic Fund to set up a Pandemic Financing Facility. The Pandemic Financing Facility could support the implementation of the CAREC Health Strategy with focus on regional (cooperation) aspects related to strengthening surveillance and early warning systems (including points-of-entry), laboratory systems, and human resources.
- 11. Institutional Arrangements for the CAREC Working Group on Health and Sub-Working Groups. The Secretariat presented the institutional arrangements for the CAREC WGH under the broader CAREC institutional structure. The proposal for creating sub-working groups for selected technical topics was put forward and accepted. The reporting requirements under the Results Framework which was shared with countries ahead of the meeting were also recognized.
- 12. The next steps were laid out and included additional recruitment under ADB technical assistance to support CAREC Health Strategy implementation, initiation of RIF activities, additional topical webinars, and sub-working group meetings.
- 13. In closing, the RIF was declared conditionally endorsed since not all countries were present. The Secretariat provided another week for feedback and for countries to submit written endorsements. The Secretariat expressed appreciation to the Government of Georgia for being the Chair of the WGH. The Secretariat also thanked the CAREC countries for their input and review of the RIF and continued cooperation and the development partners for their support.
