Open Discussion Part 1:

- *Is the CAREC Tourism Strategy, including its vision statement, guiding principles, and strategic pillars, aligned with national tourism priorities and strategies? Are there any other important principles and/or strategic areas that should be included? Or should any of the proposed initiatives be dropped?*

Open Discussion Part 2:

- *Based on countries' tourism priorities and the proposed priority tourism clusters and strategic pillars of the CAREC tourism strategy, what potential projects and initiatives with regional scope should be included in the regional tourism investment framework 2021-2025 (Appendix II)? How can different funding mechanisms be enabled?*

Open Discussion Part 3:

- *Do the proposed institutional arrangements provide a sound, effective, and flexible mechanism to ensure coordination between CAREC countries and the various agencies involved in tourism development in the region? Are there any other elements that should be included to strengthen institutional efficiency and coordination and enhance countries' ownership and commitment going forward?*

Open Discussion Part 4:

- *Are the proposed indicators in the results framework (Appendix III) adequate for monitoring and evaluating the implementation progress of the tourism strategy 2030 and the regional tourism investment framework?*
