- Hence key roles are to do economics of risk and take international action



#### Regional and National Economics of Climate Change

- Climate change is global issue but regional and national perspectives should be included to tackle this issue.
- Need for achieving a balance between economic development and environmental concerns
- Necessity for climate change adaptation to minimize climate change impacts. According to German Watch (2009), Mongolia places at the 16th most vulnerable country to the climate change among 174 countries.
- Need for developing cleaner and low carbon economic growth strategies at both regional and national levels


#### Mongolia's GHG Inventory

- Promotion of Renewable Energy Sources such as hydro/wind/solar
- Energy Efficiency Improvement: Heating boilers, household stoves, furnaces, etc.
- Efficient use of coal
