### Asian Development Bank Contribution





On April 2013, a grant agreement was signed between the Republic of Tajikistan and Asian Development Bank on Regional Improvement of Border Cervices Project, which is aimed to create and develop the Single Window system and improve the activities with border crossing points.

Also, within the framework of the Project, the "UAIS" system of the Customs Service was modernized and integrated with the "Single window system for of export, import and transit procedures".

#### О внедрении системы «Единого окна по оформлению экспортных, импортных и транзитных процедур»

В соответствии со статьей 14 конституционного Закона Республики Таджикистан «О Правительстве Республики Таджикистан» Правительство Республики Таджикистан по стан св ля ет:

1. С 1 сентября 2020 года внедрить систему «Единое окно по оформлению экспортных, импортных и транзитных процедур» и переваети сделопроизводство государственных органов и организаций в части оформления экспортных, импортных и транзитных процедур от бумяжного на электропный носитель.

 Утвердить перечень государственных органов и организаций, представляемых участникам внешнезкономической деятельности разрешительные документы и сертификаты на импорт, язспорт и тратяля товаров с использованием системы «Единое окно по оформлению экспортных, импортных и транзитных процедур» (прилагается).

3. Государственному унитарному прадприятию «Центр Единого окна» при Таможенной службе при Правительстве Республики Таджинкстан обеспечить доступ государственных органов и организаций, включенных в перечень, к системе «Единое окно по офромлению окнортных импортных и транятикых процедурь.

 Государственным организм и организациям, включенным в перечень, решить все технические и организационные вопросы для приссединения к системе «Единое окно по оформлению экспортных, импортных и транзитизх процедур».

### Pilot period of system introduction






After completion of the system development process and its testing by users, in November 2019, with the participation of all stakeholders, a pilot phase of the Single Window system was launched.

During this period, users, along with the traditional paper workflow at that time, sent applications through the system, actively identifying existing shortcomings in the business processes of the involved departments and comments from the private sector. Together with the software developer, special attention was paid to the training of future users.

#### SINGLE WINDOW SYSTEM-HOW IT WORKS



Allows foreign trade participants to send all information on import/export required by regulatory authorities, in a single form only one time and with the same channel to receive up to 22 permit documents and certificates in electronic form.



➤ The system automatically considers the permitting document "issued" if the terms for consideration of the applications by Subject exceeds the legal time frame.





- ➢ 63 points for consideration of applications of participants of foreign economic activity and issuance of permits, are connected to the system throughout the country.
- Possibility of paying for the services of the Single Window Center through an electronic wallet.
- Automatic identification of the User's status through the "Single Window" system of the Tax Committee.
- Automatic conversion of foreign currency to the national currency when forming financial obligations.
