

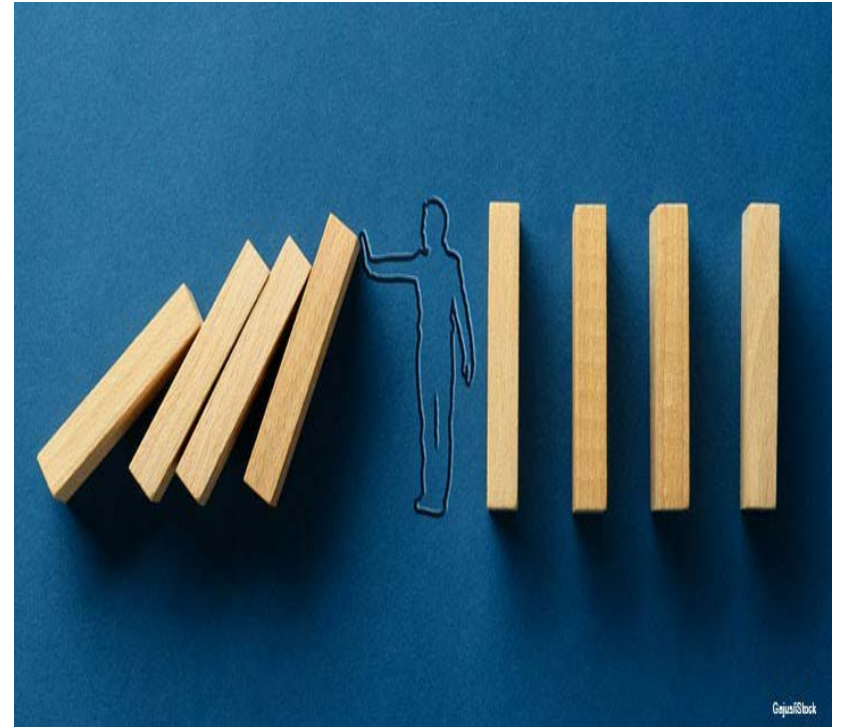
# Trade Facilitation, E-Commerce, and Paperless trade



- ACD has strived a lot to facilitated the trade for movements of goods and people;
- ACD automated almost all of customs clearance procedures to support e-commerce and paperless trade;

# Risk management

- ACD has developed the risk management **procedure and policy to assess and identify the level of risk in customs deceleration and related issues.**
- In line with the customs risk management policies, **we develop single and multiple criteria to facilitate the trade for low-risk companies and commodities.**



# E-Payment



- **The intervention of Commercial Banks:** Fortunately all the **commercial banks are now ready to collect the customs revenue and through a half electronically process its deposits to the government account.**
- **APS integration with Asycuda System:** ACD has already finalized the integration process with Afghanistan Payment System - Da Afghanistan Bank- the only step that has left behind is to sign a **MoU and start the pilot process.**
- **Asycuda integration with Automated Transfer System:** ACD is on the final stage to integrate this system with the Asycuda system as well.

# Broker, Help desk, and representative of trader

- To bring more facilitation for traders, ACD has initiated the Brokerage system, help desk, and representative of the trader for goods clearance, according to that all traders have three choices for declaration of their goods



- **Online Facilitation for Asycuda System**
  - ACD is on the final stage to launch the online access of Asycuda system, according to this all the traders will have online access to the Asycuda system and they even can declare their good pre-arrival.
- **24 hr. activation of the Asycuda system**
  - ACD has been activated the 24 hrs. Asycuda system activities.

## The building of warehouses, cold storage and parking

- ACD in line with its ongoing plan has built many warehouses, cold storage, parking and office buildings to smooth the progress of customs procedures and trade facilitations.





- **E-TIR:** ACD is about to launch the e-TIR module in Afghanistan in the near future, for trade and transit facilitation we have integrated the Asycuda system with IRU system.
- **Specific TIR line and Parking lot:** Most of the customs houses in Afghanistan have the specific line for the process of TIR consignments and they have the availability of the parking lot for TIR as well.



- **Finalized the feasibility study of Single Window**
  - Implementation of exemption Module
  - Implementation of **manifest** module ( Train line, Airlines)
  - The E-governance law is under process

## **Reforms on customs legislations and regulations on temporary measures undertaken in response to Covid-19**

- Reduced the tariff rate on some necessary items during Covid 19

## **Data Sharing and controlling measures and Automation of customs clearance**

- We have developed custom to custom data sharing and cooperation MoU with, Uzbekistan, Russia, Iran, Pakistan, China, Emirates, Egypt, India and Australia
- We have installed digital scales, Tracking devices, CCTV Cameras, in our custom houses and we are in the procurement stage of buying Cargo scanners
