

Statement by Mr. Farhod Vosidiyon Deputy Minister, Ministry of Economic Development and Trade Republic of Tajikistan 22nd Ministerial Conference Central Asia Regional Economic Cooperation Program 30 November 2023, Tbilisi

On behalf of the Tajik delegation, I welcome all participants of the twenty-second Ministerial Conference of the CAREC Program.

In the time since the Ministerial Conference last year, despite the serious events taking place in the world and a generally difficult year for all countries of the world, significant work has been done within the framework of the CAREC Program by the participating countries and multilateral institutions. The task of regional integration should first of all be to take part in global competition from a more powerful position in order to accelerate economic development, ensure its stability and improve the well-being of citizens.

We are confident that this year's activities will strengthen CAREC's characterization as a resultsoriented program and provide new impetus for further interest and increased support from multilateral institutions.
