
KEY POINTS	 Tesla CEO Elon Musk and Mongolia's prime minister on Monday talked about potential expansion and investments in the Asian country.

	 They spoke about bringing Starlink, a satellite communications terminals and services provider operated by the Musk-founded SpaceX, to Mongolia.


