GDP of China: US\$1,649.5 billion Export and Import: US\$1,154.8 billion Average GDP per capita: US\$1,273

International Road Transport in China and Regional Economy Development

 China is bordered with 15 countries with 22,000 km border line.

International road transport:

- 7.99 million passengers
- 10.53 million tons freights
- Transport routes: 140
- Border-crossings: 60

- Economic & trade development
 10 bilateral road transport
 agreements;
 - 3 multilateral road transport agreements & 1 in negotiation; Rapid trade growth between China and Central Asian countries:

In 2004, trade between China and Russia: US\$21.2 billion; between China and four Central Asian Countries: US\$5.85 billion

Possible functions of TIR in road transport & economic development

Possible functions of TIR in road transport

- TIR is an important factor for strategic development of the country and transport industry
- TIR can be applied in inter-modal transport
- TIR is of a matured and commonly used international guarantee system which has operated for decades
- TIR has been generally recognized by the Customs of many countries
- TIR is useful for establishing and improving integrated and harmonized Euro-Asian road transport market
- TIR is useful for upgrading national policies

Possible functions of TIR in economy & trade

- TIR is a important factor for globalization process
- TIR may bring breakthrough for trade liberalization between China and neighboring countries
- TIR is a key starting point for China to participate in international affairs

Possible functions of TIR in road transport & economic development

Summary

- Reduce transport and trade costs through reduction of procedures and delays in Customs clearances
- Minimize interference of non-physical barriers to transportation in border crossing
- Facilitate Customs clearances through standard procedures and documents, i.e., simplification and standardization
- Add a good practical choice for transport operators during international transport and trade
- Effectively reduce risks of smuggling and fraud
- Settle problems and disputes according to recognized convention through multilateral meetings led by international organization
- Exempt duty deposit for transport operators at border Customs

Attention to be Paid when Considering Acceding to TIR

Problems need to be considered

- Domestic legislation and international treaties
 - ----Harmonized
- Industrial administration regime
 - ----Integrated
- Traffic rights
 - ---First of all, traffic rights for China's road transport operators in neighbouring countries must be assured
- Traditional methods in road transport
 - ----need to change to meet the modernized transport
- Role of industrial association
 - ----Represent the rights/interests of transport operators

Attention to be Paid when Considering Acceding to TIR

- Issues need to be addressed
 - Safety and security of economy and trade/road transport
 ----Through resolution of human, vehicle and road
 - Rights/interests of national and foreign transport enterprises
 ----Under WTO framework
 - Transport corridor and transport facilitation
 ----Step by step
 - Harmonization of standards of infrastructure and vehicles
 ----Meet the international standards
 - International conventions, transport agreements and multilateral/bilateral cooperation and consultation mechanisms
 - ----Based on international facilitation conventions and transport agreements, long-term system
