# **TA 9500 Closing Workshop Key Messages**

Crucial role of SPS measures and institutions to ensure **safe trade** and increase **resilience** amid the challenges (pandemic, climate change, food safety and security issues)

CAREC countries remain committed to modernize SPS systems

Numerous initiatives and pilot projects contributed to building **capacity**, implementing **reforms** or business process improvements

Demonstrated use of digital tools and **innovative solutions** (e-Phyto, NSW, animal ID and traceability— with potential to **replicate or upscale** at regional level

Effective **change management** is key to risk management, integrating SPS inspection and customs control at the borders



# TA 9500 Closing Workshop Key Messages

Continued **cooperation**, constant **evaluation**, open **communications** esp. with traders and economic operators to sustain good outcomes

Plethora of good practices guides, tools, mechanisms, and technical support available to help countries adopt international standards, comply with global commitments (WTO TFA and SPS agreement), harmonize

Strong **strategic linkages** with other CAREC sectors (Health Strategy, Agriculture and Food Security Framework, Digital Strategy, Climate Change Vision)

Some proposals and opportunities for **regional cooperation**— how can our initiatives be more **strategic**, **practical and impactful**?

Technical capacities on SPS measures at selected common borders improved




