## In his Annual <u>Address</u> <u>to the People of Kazakhstan</u> <u>delivered on March 1<sup>st</sup>, 2006</u> <u>President Nursultan Nazarbayev</u> presented a Strategy to join the world top 50 most competitive countries



- "We want to see Kazakhstan as a country which is developing in accordance with the global economic tendencies...
- We have to be prepared to face with tough competitiveness and be able to use it in our favor. Kazakhstan can and has to be actively involved in multilateral international economic projects that would assist Kazakhstan to integrate into the global economy, based on our economic and geographic position and vast natural resources".



- New post-industrial policy implies a diversion of investment from the raw material sector to the manufacturing and processing industries.
- The investment rating from Moody's, Standard & Poor's, and Fitch reflects progressive economic growth and positive international investment position

### Threats:

- Growing energy prices = uncompetitive manufacturing industry
- State behavior (O&G, tax, anti-monopoly)
- Banking sector stability



### Positive factors to enter the market

- Major positive changes since 1991
- The last 5 years have been crucial
- The next 5 years sustainable growth is expected
- Kazakhstan offers good relative value in terms of risk / reward

Further expansion of the business functions and possibilities of the CCI are being planned:


- Organizing support centers for small-scale business as well as legal support centers in all regions of the country
