#### CI is a Regional Institution

 CI was founded as a regional institution, and an integral component of CAREC Program. Although during its initial years it has functioned as a "virtual" entity, such institutional arrangement has always been considered as temporary.



## CI supports CAREC 2020

- CI is identified as one of the seven operational priorities of CAREC 2020.
- The CI Strategic Knowledge Framework 2013-2017 (the SKF), endorsed at the SOM in June 2012, lays out the framework in which to enhance CI in support of achieving CAREC 2020 objectives.



# Strengthening Country Ownership

- This changing environment and context requires CI to do better, to become a knowledge powerhouse, to support achievement of CAREC 2020 goals.
- Most essential is the strengthening of CAREC countries' ownership of CI.



#### Need for a CI assessment

 It was in this spirit that the June SOM requested ADB as Secretariat to conduct a CI assessment on how best to move forward, including the issue of best institutional arrangement.



### **Moving Forward**

 Should CI continue to operate as it has been under ADB care-taking, or should it assume its own entity, and become a fullfledged regional institution of the countries?



- This assessment highlights:
  - Strategically, moving CI into the region would send a powerful message of country ownership.
  - Operationally, SKF requires capacity building for CI, which is impossible to do without a physical base or own staffing.
  - Business wise, if CI is to move in to the region in the physical modality, it would enable CI to build a reputation as a knowledge powerhouse on cooperation.

## **Build up CI in the Region**

 If a decision is made to move CI physically into the region, what would be needed to build up CI? There are a range of measures, some immediate and some over time, that need to be taken to ensure CI will be effective, sustainable, and regional.
