



CAREC 2020 Mid-Term Review: Country Consultation Meeting

4 April 2016, Tashkent, Uzbekistan

Background

The Mid-Term Review (MTR) of CAREC 2020, the long-term strategy for the CAREC Program, was endorsed by the Senior Officials of CAREC in the lead up to the 14th CAREC Ministerial Conference held in Ulaanbaatar, Mongolia, in September 2015. The MTR will be based on comprehensive consultations with member countries at both sector level (at working group meetings) and at national level. This national consultation meeting will take the form of a Focus Group Discussion (FGD) amongst government officials, think tanks, private sector and CAREC secretariat to review the current status of CAREC activities in the region and have an open discussion between government officials, think tanks and private sector on future priority areas for regional cooperation and new possibilities to strengthen regional integration under CAREC. The FGD will also consider continued relevance of the CAREC strategy in the face of changing circumstances, national priorities and development plans of member countries. The outcome of these discussions is expected to be a shared understanding between Uzbekistan and CAREC secretariat on recommended strategic, implementation and institutional refinements to the CAREC program over the remaining period of the CAREC 2020 strategy and into the longer term.
