Representative of CFCFA Chairman:

- presented the CFCFA and emphasized the necessity of development of public-private partnership mechanism in the region;
- informed about the main directions of CFCFA activity, action plan, results achieved, particularly about holding of major international events in CAREC countries including those with participation of customs, railways and forwarders;
- emphasized the necessity of government support in formation of associations of forwarders and logistics of Tajikistan. Kazakhstani experience has already proved the efficiency of such organization in the development of business and transport industry;

- told about experience of Kazakhstan in public-private partnership development, about the decisions of international conference on partnership in the sphere of IT for railway transportation which was held in July 2010 with the support of ADB;
- informed about the coming CFCFA events, including annual meeting in August; discussed the issues of agenda;
- informed about the meeting to be held on 19-20 July in Almaty which will be dedicated to the work of forwarders of Tajikistan and Kazakhstan under the conditions of Customs Union, and proposed the Ministry to participate in that meeting.

Deputy Minister of Transport of Tajikistan:

- informed about the development of transport infrastructure of Tajikistan and actions of Ministry in supporting the associations;
- informed that the Association of Forwarders of Tajikistan was established, but actually it does not work;
- made a request for the representative of the CFCFA Chairman to hold separate meetings with local associations ABBAT, AFT (association of forwarders), AIATT, to explain the CFCFA tasks and inform them about the experience of Kazakhstan in formation of associations and principles of interaction with governmental authorities;
- expressed confidence that the CFCFA will promote strengthening of business and development of transport sector in Tajikistan, and that the Ministry is ready to support its start-up activities;
- endorsed the idea of holding a meeting on the work of forwarders of Kazakhstan and Tajikistan and informed that the Ministry will send its representative to participate in this event:
- instructed international department of the Ministry to organize a separate meeting with the CFCFA representative and invite representatives of governmental bodies, private companies and associations to this meeting.
