

CENTRAL ASIA REGIONAL ECONOMIC COOPERATION PROGRAM NATIONAL FOCAL POINTS' MEETING 12th October 2021

SUMMARY OF PROCEEDINGS

I. Introduction

- 1. A Central Asia Regional Economic Cooperation (CAREC) Meeting with National Focal Points (NFPs) was held virtually on 12th October 2021. Delegations from CAREC member countries participated along with representatives of CAREC development partners (DPs) and the CAREC Institute (CI). Mr. Elnur Aliyev, Deputy Minister, Ministry of Economy of Azerbaijan, chaired the meeting. Mr. Yevgeniy Zhukov, Director General, Central and West Asia Department (CWRD), Asian Development Bank (ADB) and Ms. Teresa Kho, Director General, East Asia Department (EARD), ADB co-chaired the meeting.
- 2. The objectives of the meeting were to: (i) Review the progress made in formulating the CAREC Health Cooperation Strategy 2030, CAREC Digital Strategy 2030, CAREC Development Effectiveness Review, CAREC Regional Infrastructure Projects Enabling Facility, and in development of the CAREC Water Pillar; (ii) Review the progress of the CAREC Institute; and (iii) Deliberate on the proposed theme and major deliverables for the 20th CAREC Ministerial Conference (MC) to be held virtually in November 2021. The chair and co-chairs emphasized that the need for regional cooperation became more apparent than ever in enabling a sustainable and inclusive recovery while strengthening resilience in CAREC countries as the COVID-19 pandemic persists, governments continue to enact necessary mitigation and containment measures. It was noted that the CAREC made considerable progress under CAREC 2030's five priority clusters, despite the challenges created by the pandemic, including the development of the CAREC Health Strategy 2030 and the CAREC Digital Strategy 2030. These two strategies will provide innovative integrated solutions and have practical value in post-pandemic environment to support achieving program's objectives. The agenda and list of participants are attached as Appendix 1.

II. Meeting Highlights

- 3. The meeting discussed key issues about five initiatives presented during the session.
 - a. **CAREC Health Cooperation Strategy 2030**: The meeting took note of the progress made in preparation of the CAREC Health Cooperation Strategy 2030. Member countries expressed their commitment to regional cooperation and integration in the health sector. Member countries, while offering some comments and suggestions, generally agreed to the submission of the draft strategy to the MC for its endorsement, taking into account the People's Republic of China's comments. It was suggested that the strategy consider addressing issues related to acceptance of COVID-19 test and vaccination certificates for travelers among member countries. Second, it was

recommended that the CAREC strategy focus on economic and/or financial aspects of the health sector, where ADB has a comparative advantage. A member country requested that comments from its other government departments and agencies would be sought, taking into account its one health approach. It was proposed to consider collective research activities in a few important areas of combating COVID-19. Support from the CAREC program was also requested to explore the establishment of international and regional instruments, including a Central Asian Regional Center for Epidemiology, Virology and Bacteriology.

- CAREC Digital Strategy 2030: The meeting noted that the CAREC Digital Strategy 2030 will be an important instrument to prepare the region's digital foundations and lead to improved digital connectivity. The strategy would also contribute to creating the necessary digital infrastructure and building a favorable environment for businesses, such as e-commerce, through harmonization of relevant legislations. The member countries reaffirmed their commitment to the finalization and submission of the CAREC Digital Strategy 2030 to the MC, in principle, while providing their guidance for incorporation in the final draft. Kazakhstan proposed that CAREC hosts the first CAREC Digital Strategy 2030 Steering Committee meeting at the Digital Almaty Forum, an annual international forum, planned for February 2022. It was also suggested that the strategy should consider increasing its focus on building an enabling environment for digital economy; prioritizing key implementation areas in line with CAREC's strengths; leveraging existing resources for development and private sector partners to fund selected pilot projects; and advancing data sharing in a gradual manner. Lastly, queries and requests for revisions on details of the strategy were received, e.g. to replace the "CAREC Job Opportunities and Mobility Platform" with the "CAREC Employment Service Platform" and reconsider the feasibility of integrating the social protection services platform into the proposed one-stop shop.
- c. CAREC 2030 Development Effectiveness Review: The meeting was informed of progress made for the preparation of the first Development Effectiveness Review (DEfR) under the CAREC 2030 Strategy. The Review found that implementation of the 2030 Strategy and progress made under various clusters are on track to achieve strategy objectives, despite challenges faced during the review period such as the COVID-19 pandemic. The report also addressed challenges and opportunities and offered recommendations for going forward. Member countries acknowledged that the DEfR report provided a comprehensive assessment based on the agreed methods, assessment criteria, and approach. The Secretariat noted that further feedback from member countries could be provided by the following week to finalize the report.
- d. CAREC Regional Infrastructure Projects Enabling Facility: Most member countries acknowledged the need for reducing infrastructure gaps in the region and affirmed their support for the establishment of CAREC Regional Infrastructure Projects Enabling Facility (RIPEF). Some recommendations were provided by member countries. Ideas about possible projects such as upgrading border services and streamlining visa processes were proposed. One member country recommended to further assess the necessity and feasibility of RIPEF to avoid any potential duplication with other DPs; mobilize and leverage resources from DPs including ADB; continue to engage member countries for consultation and incorporate their views; and carry out relevant work on a consensus basis. Turkmenistan suggested considering public-private partnership mechanisms for establishing the facility.

- e. **Development of CAREC Water Pillar**: The meeting endorsed the development of the CAREC Water Pillar, noting its high level of relevance and significance given the water needs, geography and climatic features of the CAREC region. Member countries appreciated that the scoping study addressed relevant water-related challenges in the region, such as Aral sea issues. For the finalization of the scoping study, member countries encouraged focusing on fair and reasonable use of water resources and the formation of a coordinated regional policy, considering social, economic and environmental interests of countries in Central Asia region.
- 4. CAREC Secretariat thanked NFPs and country delegates for their support and thoughtful feedback on the new initiatives. The Secretariat also noted observations and suggestions on the draft CAREC Health Strategy 2030 and the CAREC Digital Strategy 2030. The Secretariat committed to consider the advice and revert for any clarifications before their finalization and submission to the CAREC MC. Also, it was reiterated that the member countries could share their comments on DEfR by the following week.
- 5. The CAREC Institute (CI) apprised the meeting of the progress made in its research and capacity building programs. CI completed 12 research projects and 11 capacity building activities, which shifted to a virtual e-learning platform in line with the needs of the time. CI's Strategy 2021-2025 was deliberated at the 11th Governing Council meeting held in July 2021. The meeting noted, with appreciation, CI's increased contribution to knowledge and research in the region despite the pandemic through improved quality of knowledge work, increased use of the CAREC Regional Integration Index, and expanded partnerships. It was suggested that CI sustain its efforts in enhancing quality of its knowledge products and increasing their visibility; continue to improve its institutional capacities and explore innovative solutions for financial sustainability; and consider conducting comparative analysis on CAREC Advanced Transit System and the International Road Transports Convention regime. In addition, all CAREC members were encouraged to actively participate in the ADB-CAREC Institute Visiting Fellow Program, CAREC Think Tank Network Forum and other exchanges activities.
- 6. The CAREC Secretariat informed the meeting that the 20th Ministerial Conference (MC) is planned to be held virtually on 17th November 2021, with the theme "Connectivity, Cooperation, and Resilience in a Digital Era". The MC will deliberate on the ways to enhance regional cooperation in the post-pandemic period by adopting a digital transformation agenda, considering the cooperation needed in the health sector to build resilient societies, and discussing measures to improve physical and digital connectivity that will help poverty reduction and improve the economic prospects of the region. The MC will consider the endorsement of the CAREC Health Strategy 2030 and the CAREC Digital Strategy 2030, and the adoption of a joint Ministerial Statement. The draft statement will be shared with member countries for feedback and confirmation prior to the MC. Finally, support from NFPs was requested to ensure the participation of their respective Ministers. The meeting appreciated the preparatory work conducted thus far in preparation of strategies, other key initiatives to finalize the deliverables and arrangements for the 20th MC.
- 7. The meeting expressed its appreciation to the Government of Azerbaijan, particularly the Ministry of Economy, for chairing the meeting. The meeting also expressed its gratitude to ADB and the CAREC Secretariat for helping organize and conducting the meeting, and extended thanks to CAREC's DPs present in the meeting for their support.
