- > A Diagnostic Mission to China Customs in March 2006
- The objective of the mission
 - 1. To explain the importance of the FoS
 - 2. To assist China Customs in consulting with other Government Agencies
 - 3. To identify the current position on implementation of FoS and potential problems
 - 4. To assist establishing an action plan
 - 5. To identify the steps to get assistance from WCO

Diagnostic Mission (II)

- > The key areas to examine
 - 1. Legislation
 - 2. Procedures
 - 3. Information technology and communications
 - 4. Governance
 - 5. Co-ordination of development projects of China Customs
 - 6. External relationships

Diagnostic Mission (III)

Overall Recommendation

- > The introduction of a 'single window' approach
- The introduction of strategic risk management
- Consolidation of the Customs rules and decrees to assist with transparence and consistency

Diagnostic Mission (IIII)

Overall Recommendation (continue)

- The acceptance of electronic cargo and goods delectation only (without paper requirement)
- > Two phases clearance
 - 1. Security clearance
 - 2. Fiscal and trade policy clearance
