

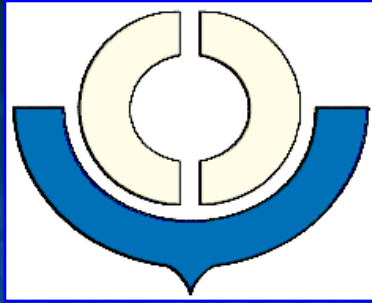

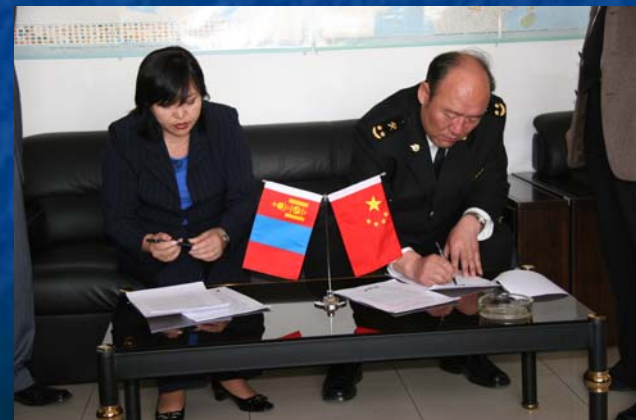


As signatories of the Revised Kyoto Convention, CAREC member countries have committed to customs reform and modernization, including joint customs control



The "Agreed Minutes of the Meeting between the Customs Administration of Mongolia and the Customs Administration of People's Republic of China" was signed during the 4th CCC Meeting in Ulaanbaatar, Mongolia on 8 September 2005

During the April 2006 meeting in Huhe Haote, customs representatives from PRC and Mongolia discussed the direction and scope of bilateral cooperation



One of the outcomes of this meeting was the establishment of an Expert Group and a Working Group with well-defined roles and responsibilities.

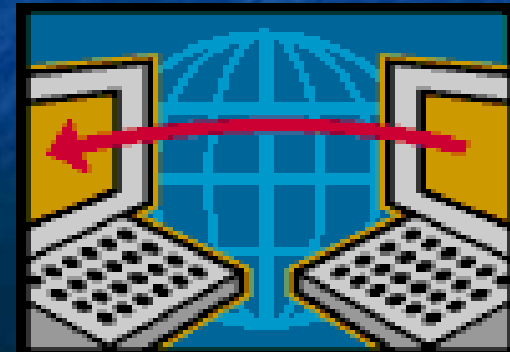
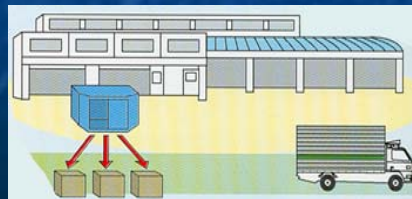
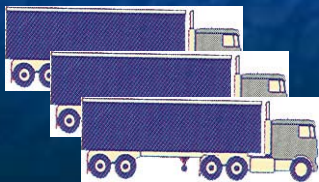
# Composition of the expert group in Mongolian Customs
