



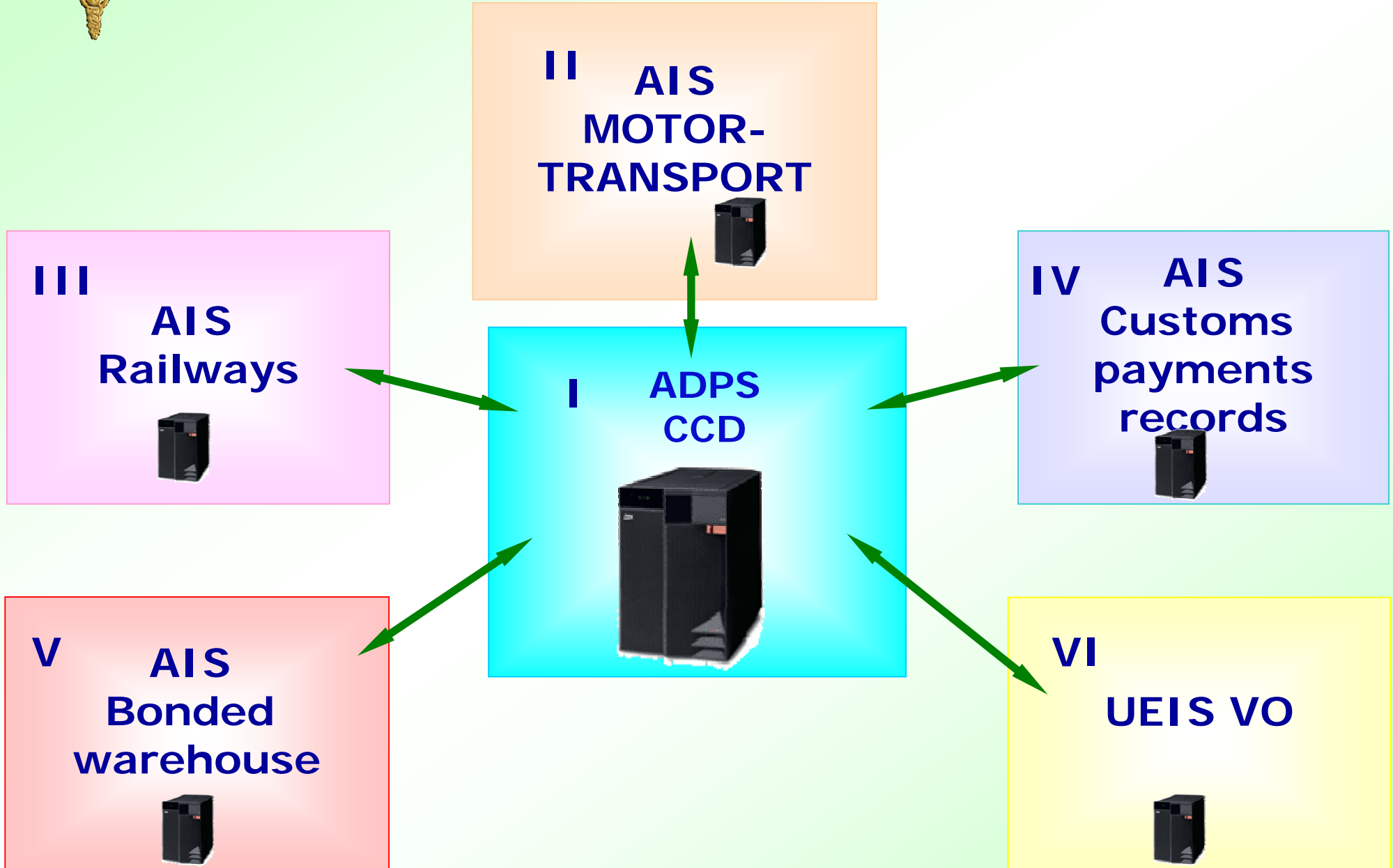

Structure of the UAIS of the SCC of the RUz





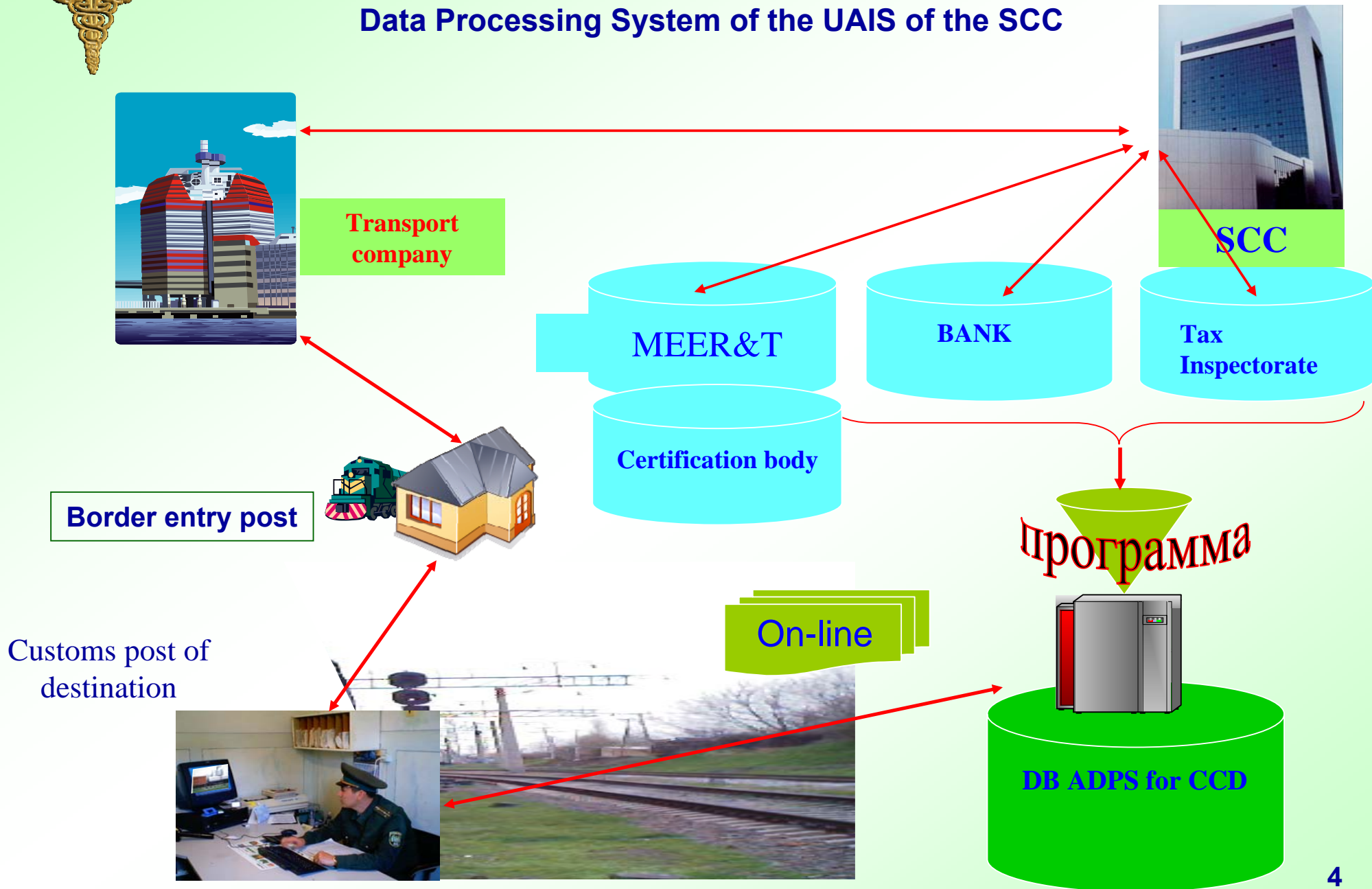
The UAIS of the SCC of the RUz enables to interact in a real-time mode with similar systems of the STC, CB, MEER&T and the Chamber of Accounts. In particular, the AIS Railways has an interface with software of PPV, TGNL, SMGS installed at the State JSC Railways company Uzbekistan Temir Yullari, the system Customs Payments Records with the single banking system Bank-Customer, and the system Bonded Warehouse with the application of the Airway Bill system, functioning at the NAC Havo Yullari.

Interface of the above mentioned systems enables the customs bodies to timely control the delivery of goods to the destination border post, to control customs value and collection of customs payments, to maintain automated control of customs inspection and storage of goods at bonded warehouses.

The UAIS system of the SCC will include after development such systems as Customs Offences, Customs Expertise, Electronic Declaration and the existing UEIS VO will be improved.

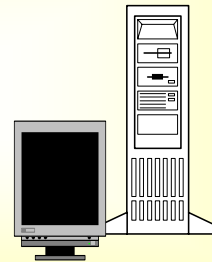

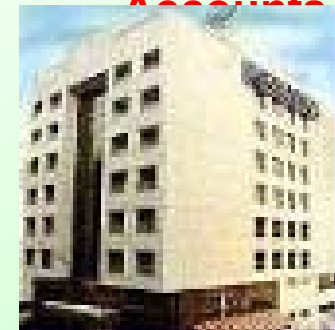

- Access and obtaining of reliable data on bonded goods to all controlling bodies at each stage of customs clearance to ensure information transparency of decisions of customs officials;**
