

CAREC Institute Progress Report/ Work Plan for 2010 – 2011

Senior Officials' Meeting on Central Asia Regional Economic Cooperation 16 – 17 April 2010 Manila, Philippines

SUMMARY HIGHLIGHTS

- Key progresses since the 8th Ministerial Conference in Ulaanbaatar, Mongolia, in October 2009 include:
 - On professional development and training, the second Executive Leadership Development Program (ELDP) was held in Singapore on 29 March-3 April 2010 for CAREC senior executive officials and the Public Sector Management Courses (PSMC) was held in November 2009 in Kazakhstan and Kyrgyz Republic for middle-level government officials. ELDP covered executive leadership practice, public sector management and finance, strategic planning, and negotiation and communication skills and PSMC exposed participants to modern tools and best practices in the use of public resources. A public-private partnership (PPP) workshop "Lessons from Asian Experience" held in Chengdu, PRC in November 2009 promoted understanding of the PPP concept and practices;
 - On research, a "CAREC Institute Research Workshop" was held in October 2009 in Almaty, Kazakhstan participated in by leading international researchers. Preparatory work for the CAREC Program Results Framework has progressed to enable performance monitoring with relevant indicators; and
 - On outreach, the CAREC Institute web site at <u>www.carecinstitute.org</u>, serves as a hub for knowledge and information on regional economic cooperation. The Russian mirror site for major web pages has also been developed. The Institute supports events to raise awareness and stimulate discussion on regional issues. A conference in Dushanbe, Tajikistan on 11-12 November 2009 entitled "Renewable Energy in Central Asia: Creating Economic Sustainability to solve Socio-Economic Challenges" is an example of such.
- New initiatives for discussion at the SOM in April 2010 are:
 - A concept of the study on "CAREC: 10 Years of Cooperation and Moving Forward" has been prepared for discussion at the Senior Officials' Meeting in April 2010. This study will examine CAREC's evolution and achievements in the past ten years.
 - An assessment of the CAREC Institute activities will be conducted to review the outcomes of CAREC Institute activities and to determine an appropriate approach for the next phase of development. An outline of CAREC Institute Performance Assessment Report (CIPAR) will be presented at the SOM in April 2010.

I. OVERVIEW OF PROGRESS

1. Since the 8th Ministerial Conference in Ulaanbaatar, Mongolia, in October 2009, progress was seen in all the areas of CAREC Institute activities defined in the work plan for 2009-2011, i.e., professional development and training, research, and outreach. Key achievements¹ include:

- On professional development and training, the second Executive Leadership Development Program (ELDP) was held in Singapore on 29 March-3 April 2010 with participation of approximately 30 CAREC senior executive officials. ELDP covers executive leadership practice, public sector management and finance, strategic planning, and negotiation and communication skills. The Public Sector Management Courses Program (PSMC) were held in November 2009 in Kazakhstan and Kyrgyz Republic for middle-level government officials. PSMC exposes participants to modern tools and best practices in order to strengthen their work within government institutions and enhance accountability, transparency, and efficiency in the use of public resources. With participation of approximately 30 CAREC officials, a public-private partnership (PPP) workshop entitled "Lessons from Asian Experience" was held in Chengdu, PRC in November 2009. The workshop strengthened the participants' understanding of the PPP concept and practices.
- On research, a "CAREC Institute Research Workshop" under the Flagship Research Programs was held in October 2009 in Almaty, Kazakhstan participated in by leading international researchers. Since the endorsement of the concept paper at the 8th Ministerial Conference in Ulaanbatar, preparation work for a CAREC Program Results Framework has progressed to enable performance monitoring with relevant indicators. The indicator sets have been prepared for endorsement at the Senior Officials' Meeting in April 2010.
- Concepts of new research initiatives have been prepared for discussion at the Senior Officials' Meeting in April 2010. Such initiatives include: a study on "CAREC: 10 Years of Cooperation and Moving Forward", which will examine CAREC's achievements and future directions, and a CAREC Institute Performance Assessment Report (CIPAR), which will assess CAREC Institute activities. These new initiatives will lead to recommendations on the next phase of CAREC development.
- On outreach, the CAREC Institute web site at <u>www.carecinstitute.org</u>, serves as a hub for knowledge and information on regional economic cooperation in the region. The Russian mirror site for major web pages has been developed and will regularly be updated. The Institute supports events at the national and regional level to raise awareness and stimulate discussion and debate on regional issues. A conference in Dushanbe, Tajikistan on 11-12 November 2009 entitled "Renewable Energy in Central Asia: Creating Economic Sustainability to solve Socio-Economic Challenges" was an example of such supports by the Institute.

II. KEY DEVELOPMENTS

A. Professional Development and Training

2. The Institute's professional development and training program seeks better knowledge and skills in areas related to regional cooperation. A CAREC training needs assessment² recommended the work through two streams:

- (i) The Leadership Development Initiative (LDI) is currently being implemented in collaboration with the Lee Kuan Yew School of Public Policy, National University of Singapore. It comprises:
 - Executive Leadership Development Program (ELDP). ELDP aims to provide senior executives with the analytic tools and skills set that they need to proactively deal with the challenges they encounter in leading change and achieving results. It targets executive leadership practice; public sector management and finance; strategic planning; and negotiation and communication skills. The first delivery of the ELDP in August 2009 received very satisfactory ratings from the 29 CAREC officials who participated. One Afghanistan official has been nominated and, if selected, will be given a full scholarship in LKY School's Masters in Public Policy Program. Based on the evaluations received from the 1st ELDP, efforts have been made to improve the 2nd ELDP (scheduled for 29 March/3 April 2010) in terms of tailoring the content more to the situation and challenges faced by CAREC officials.
 - Public Sector Management Courses Program (PSMC). PSMC aims to provide middle-level government officials with updated practical knowledge and skills in public sector management and finance. The course exposes the participants to modern tools and best practices in order to strengthen their work within government institutions and enhance accountability, transparency, and efficiency in the use of public resources. More than 80 government officials participated in the 1st and 2nd deliveries of PSMC held in November 2009 in Astana, Kazakhstan and Bishkek, Kyrgyz Republic. Feedback from the participants in Astana and Bishkek demonstrated an overall satisfaction with the PSMC, but they also provided useful suggestions for enhancing the course. Possible improvements under consideration include extending the PSMC from two days to four days; incorporating more content specific to each country's public sector issues; and collaborating with CAREC region-based institutions to co-deliver the course.

(ii) Sector and committee-led training and workshop assistance to CAREC sector committees on issues relevant to their business areas.³

• **Public-Private Partnership (PPP) Workshop**. "Lessons from Asian Experience" held in Chengdu, PRC in November 2009, was an opportunity for the participants to deepen understanding about PPP concept and practices by sharing the PPP cases in Lao PDR, Philippines and PRC. This workshop was in line with the **CAREC**

Program-Private Sector Development Initiative endorsed at the 7th Ministerial Conference.

• Currently, the Institute, in coordination with Transport Sector Coordinating Committee and Trade Facilitation Coordinating Committee, is formulating a capacity building framework for transport and trade facilitation aimed at maximizing synergy between the two sectors

B. Research Program

3. The Institute aims to generate new knowledge, innovation, and recommendations to support regional cooperation. The research program will provide intellectual content on transport, energy, and trade. It will also raise the capacity of research institutes in CAREC countries. The Institute pursues such research program objectives through four streams:

- (i) creation of a shared knowledge and information base for each of the CAREC priority areas;
- (ii) flagship research programs to examine broad and fundamental questions affecting regional cooperation and its contribution to economic development in the CAREC countries;
- (iii) a small research grants program to encourage research by researchers and institutes in the CAREC countries that will advance regional cooperation; and
- (iv) issue-specific papers or studies responding to requests for information or analysis from Senior Officials' Meetings, Ministerial Conferences, or sector committees. The research program activities may also include papers or studies to address issues related to institutional arrangements for the CAREC Program, impact evaluation, or second-tier activities.

4. Key achievements on the research program area since the 8th Ministerial Conference in Ulaanbaatar in October 2009 include:

(i) Flagship Research Programs: The program is being implemented with world-renowned academic institutions in collaboration with highly regarded research centers in the CAREC countries. Research with leading academic institutions is ongoing in five areas⁴: (i) The Influence of Space and the Impact of Regional Cooperation on the Growth of the CAREC Countries; (ii) Management of Resource Revenues in the CAREC Region; (iii) Macroeconomic Policy Issues in the CAREC Countries; (iv) Structural Change in the CAREC Region; and (v) Impact Evaluation of ADB Projects in the CAREC Region. A "CAREC Institute Research Workshop" was held in October 2009. It brought together leading international researchers and grant recipients from the CAREC region. Researchers presented drafts of their papers⁵, and during the workshop options for collaboration were reviewed. Summary of the research will be published in *CAREC Notes* in 2010.

- (ii) The Impact Evaluation Pilot Studies: As part of the flagship research programs, rigorous impact evaluation exercises are pilot-tested for two CAREC transport projects. The objective of the work is to assess the CAREC transport projects by precisely measuring their impacts controlling for other possible factors. Baseline surveys were conducted on two CAREC road sections: (a) CAREC Corridor 1b, Taraz to Korday, Kazakhstan; and (b) CAREC Corridor 1c, Bishkek to Torugart, Kyrgyz Republic.
- (iii) **The Small Research Grants Program**⁶: The Small Research Grants Program encourages research by local researchers and institutes on regional cooperation in the CAREC countries relevant to CAREC priority areas. Under the second round of the program initiated in December 2008, six researches in trade policies, and trade and economic cooperation areas are now ongoing. The first draft research papers have been submitted to the secretariat and final papers will be produced in the second quarter of 2010.
- (iv) CAREC Program Results Framework: Since a request was made by the Senior Officials' Meeting in May 2009, the work on a CAREC Program Results Framework has progressed. The draft results framework concept paper was endorsed by the Senior Officials' Meeting in October 2009. Indicator sets corresponding to CAREC Program goals and objectives have been prepared for endorsement of the Senior Officials' Meeting in April 2010, which will enable tracking progress and achievements of the CAREC programs.
- (v) Support for Cross-Border Transport Agreement (CBTA): Based on a request from Tajikistan and Kyrgyz Republic to continue facilitating the negotiation of Cross Border Transport Agreement between and among Tajikistan, Kyrgyz Republic and the People's Republic of China, which would then be open for participation by other CAREC participating countries at a later stage, the CAREC Institute has provided technical and legal expertise to draft the agreement and provide explanatory notes on specific issues that require further understanding by the contracting parties. The agreement is targeted to be signed at the 9th CAREC Ministerial Meeting in October/November 2010.

5. Concepts of new research initiatives have been developed for discussion at the Senior Officials' Meeting in April 2010. Such initiatives include:

- A Study on "CAREC: 10 Years of Cooperation and Moving Forward", which will examine CAREC's achievements, and formulate recommendations for CAREC in moving forward to enhance its cooperation.
- (ii) A CAREC Institute Performance Assessment Report (CIPAR),⁷ which will assess the CAREC Institute activities to generate recommendations and suggestions for 2nd phase CAREC Institute activities.

C. Outreach and Dialogue Program

6. The Institute's outreach and dialogue program extends the impact of the training and research programs more broadly, and inform a wider audience of the goals, work, and achievements of the CAREC Program. The Institute is pursuing activities in the following areas:

- Web site development: A CAREC Institute web site⁸ (www.carecinstitute.org) was launched as a new hub for knowledge and information on regional economic cooperation in the region. The site, in English and Russian, provides easy access to a wide range of documents related to the CAREC Program, the CAREC Institute, and the priority areas of transport, trade facilitation, trade policy, and energy, as well as country information, and projects and research databases. Since its launch in October 2009, the Institute has started to monitor actual usage and access to the site. During the period of December 2009 to February 2010, the increased number of visitors and website traffic from search engines and referring sites indicate that the website has steadily moved forward to be a key source of knowledge and information. Monitoring the usage and access to the site will be continued and the results will be reported in this Progress Report regularly.
- Seminars, conferences, and events: The Institute supports events at the national and regional levels to raise awareness and stimulate discussion and debate on regional issues. The Institute supported a conference in Dushanbe, Tajikistan on 11-12 November 2009 entitled "Renewable Energy in Central Asia: Creating Economic Sustainability to solve Socio-Economic Challenges." The conference was organized by Carnegie Endowment for International Peace, the Joint Stock Company SystemAvtomatika, with support from the Government of Tajikistan and the Ministry of Energy and Industry of Tajikistan. The conference brought together participants and speakers from Central Asia and Afghanistan, as well as the United States and Europe and included academic and scientific experts on renewable energy, business leaders involved in practical applications of renewable energy resources, and representatives of international organizations and financial institutions.

III. WORK PLAN IN 2010-2011

7. Priorities for 2010-2011⁹ include:

1. Professional Development and Training

- Third delivery of the ELDP in Singapore
- Succeeding PSMC deliveries in Azerbaijan, Tajikistan and Uzbekistan in mid-2010, followed by Afghanistan, People's Republic of China, and Mongolia in 2011.
- Awareness Workshop on PPPs in Tajikistan and Uzbekistan in June 2010
- Capacity development activities of sector committees including CAREC Electricity Regulators Forum

IV. KEY ISSUES

8. **Study on CAREC Institute Performance Assessment**¹⁰: An assessment of the CAREC Institute activities will be conducted to review the outcomes of CAREC Institute activities and to determine an appropriate approach for the next phase of development. The assessment of the Institute activities will examine the Institute's early accomplishments, the current needs of the CAREC Program as compared to those in 2007, the capacities of other institutions and networks in the region, and the sustainability of financing. The findings of the assessment will generate recommendations for a revised and updated CAREC Institute Prospectus, if necessary, and a work plan for 2012-2014. An outline of CAREC Institute Performance Assessment Report (CIPAR), including (i) objectives, (ii) coverage of assessment, (iii) methodology, (iv) assessment criteria, and (v) implementation plan, will be presented for the consideration of the Senior Officials' Meeting in April 2010.

Appendix 3: Overview of CAREC Institute Research Program, 2009-2011

The CAREC Institute research program for 2009-2011 covers five areas.

1. The Influence of Space and the Impact of Regional Cooperation on the Growth of the CAREC Countries

This research area will examine how greater regional cooperation and a greater cognizance of economic factors at the spatial level can facilitate growth in the CAREC countries. It will identify possible future avenues for empirical work in this area.

Specific questions to be studied under this program are:

- The most widely used economic policy tool for regional cooperation is the reduction of trade barriers, which is supposed to lead to greater integration of economies. The analysis will assess the degree of cooperation achieved so far within CAREC and the scope for further trade integration.
- Geography and economic space are major constraints on the economic development of the CAREC countries. Research will consider the insights that regional growth theory can give on the possible development of the CAREC countries, especially in the light of recent developments in spatial econometric modeling.
- Review analytical work on regional integration and outline how this needs to be reformulated and applied to the particular circumstances of CAREC. It will outline the methods and findings of empirical work on integration, and discuss application of these methods to CAREC.

2. Management of Resource Revenues in the CAREC Region

CAREC countries are experiencing resource booms. This research area will focus on three issues:

- It will outline best practice for managing resource revenues; this could include the upstream issues of fiscal regimes and contractual relationships with resource companies, and will address the choices that have to be made between spending or saving resource revenues.
- It will review country experiences. The objective is to identify key decision points faced by policy makers, as well as to understand when these decisions have been right or wrong, and the forces that led to these outcomes.
- It will identify key areas where the CAREC region differs from others, and will outline how policy may need to be adjusted to take into account these circumstances.

3. Macroeconomic Policy Issues in the CAREC Countries

Evidence-based guidance to the appropriate policy structures that will support enhanced regional cooperation to address the major policy challenges facing CAREC countries. Some of the areas that this project will address are as follows:

- Define the key economic challenges facing CAREC economies.
- Develop a macroeconomic risk assessment framework in the context of the global financial crisis. Integral to this aim is the examination of the modern monetary macroeconomic framework on full employment and price and currency stability.
- Outline strategies to develop public infrastructure to enhance energy cooperation, water provision, climate change responses, and human capital development and integrating this into the fiscal and monetary policy framework.
- Design a national skills development framework to build long-term productive capacity in the CAREC population.
- Design regional employment strategies that can address poverty and income insecurity and provide pathways to skill development to underpin more consistent and higher productivity economic growth that benefits the population of the CAREC region.
- Discuss recent developments in macroeconomic theory and policy in the context of the "new consensus macroeconomics". One key policy implication is what has come to be known as "inflation targeting".

4. Structural Change in the CAREC Region

Structural transformation is the process by which countries change what they produce and move from low-productivity, low-wage activities to high-productivity, high-wage activities. The purpose of this research area is to use emerging methodologies to analyze CAREC countries' opportunities for structural transformation, in an effort to better understand past economic performance and accelerate future economic growth.

5. Impact Evaluation of ADB Projects in the CAREC Region

This research program analyzes impacts of ADB projects in the CAREC countries. The central impact evaluation question is what would have happened to those receiving the intervention if they had not in fact received the program. Likewise, an impact evaluation assesses a program's performance in attaining well defined objectives against an explicit counterfactual, such as the absence of the program. "Impact" is the change that can be casually attributed to the program.

Appendix 6: Concept Note: Study on CAREC Institute Performance Assessment Report (CIPAR)

I. BACKGROUND

1. The CAREC Institute Prospectus, endorsed at the 6th CAREC Ministerial Conference in November 2007, calls for an assessment of the Institute following its initial three years of operations.¹¹ Although the CAREC Institute has been fully operational for only a little over one year, an assessment of the Institute will be conducted to determine an appropriate approach to the next phase development of CAREC Institute programs. The assessment of the CAREC Institute will focus on examining the Institute's completed and on-going activities and the current needs of the CAREC Institute programs.

2. This concept note of the study on "CAREC Institute Performance Assessment Report (CIPAR)" presents the objective, scope, methodology, and implementation arrangement and their timelines of the performance assessment exercise to be conducted through 2010.

II. OBJECTIVE

3. The ultimate objective of CIPAR is to generate recommendations for a revised and updated CAREC Institute Prospectus and a work plan for 2012-2014. The draft CIPAR with recommendations will be presented for the consideration of the 9th Ministerial Conference.

4. The CAREC Institute was established as a virtual entity with a unique objective of becoming a region-based institution covering CAREC's specific needs for research, training, and knowledge solutions to common problems and more effective regional cooperation. The mission of the CAREC Institute is to enhance the quality of regional cooperation by generating world-class knowledge resources in the priority areas of transportation, trade, and energy, which will lead to greater capacities for regional cooperation and accelerated economic growth in Central Asia. The assessment will be conducted from the perspectives of relevance to the Institute's objective and mission of each of the CAREC Institute activities, and efficacy, efficiency and sustainability of each activity and an aggregation of activities of the CAREC Institute.

III. SCOPE and METHODOLOGY¹²

5. Assessment in this CIPAR will primarily focus on the CAREC Institute's activities and their "aggregations", i.e., assessment on each area of activities (professional development and training, research and outreach). Generally performance assessment is conducted on completed activities or programs and focuses primarily on outcomes from the activities or programs. But considering the fact that the CAREC Institute is still at an early stage of its development, the performance

assessment under the CIPAR exercise will also cover on-going activities to serve an interim assessment of impact for refinement of program design.¹³

6. In order to maintain the maximum possible objectivity in the process, aspects of conventional approaches as indicated in Table 1 will be used, though the actual approaches taken in the CIPAR exercise will be in a mixed form:

7. A "Two-Tiered Contribution Analysis" will be considered in the CIPAR. This analysis is based on the wide and diverse collection of data, information and informed opinion about individual activities, its distillation and consideration 'on balance' to form an assessment for each activity (Tier 1). The assessment results will be expressed of "outstanding", "high", "medium", "low" or "negligible" impact in terms of relevance and efficiency (negative impacts are mentioned as such but not ranked). Tier 2 is an aggregation of activity assessments and consideration of their interactions on the overall program's relevance and efficiency. Outputs of each tier provide options for enhancing relevance and efficiency at both activity and overall program levels.

8. Assessments of CAREC Institute activities will be undertaken using the suite of approaches with available participants and concerned persons from relevant agencies, training and research partners, MIs and regional institutions. Specifically, the instruments to be used in the CIPAR will include the following¹⁴ and the corresponding instruments to assessing each activity is in Table 2:

9. As the objective of the CIPAR is to generate recommendations for a revised and updated CAREC Institute Prospectus and a Work Plan 2012-2014, assessments of activity areas will focus on their future relevance. Assessing quality is difficult for short-term training activities and in other circumstances relies on examination of materials, delivery staff and mechanisms and career-impacts on participants. For research, the utility of research results and random informed assessments of research papers and outreach materials will be instructive. The overall performance of the CAREC Institute will be assessed in a manner that can enhance its continued development by offering suggestions for each activity and activity area and for program management. The analysis will be based on three tasks:

- assessments of each activity by consideration of the 'weight of evidence' to make an informed judgment;
- use of same information to consider means of enhancing relevance and efficiency; and
- consideration of activity area outcomes on a whole-of-program basis in keeping with the collaborative ethos of the CAREC Institute.

IV. Implementation Arrangements and Timelines

10. Implementation of CIPAR exercise comprises three phases; (i) assessment preparatory phase, (ii) assessment conduction phase, and (iii) analysis and recommendation production phase. In the preparatory phase, the outline of CIPAR with scope, methodology, criteria and implementation arrangements are defined, and assessment tools such as questionnaires, focus group discussion checklists are prepared. In assessment conduction phase, extensive interviews, review of documents are conducted using the above-mentioned approaches and instruments. Broader discussion on the capacities of other institutions and networks in the region, pros and cons of "virtuality" of the Institute, possibility of diversification of funding will be conducted. In the

analysis and recommendation phase, collected assessment activities will be synthesized and summary of "broader discussion" will be prepared. A CIPAR with recommendations will be drafted by CAREC secretariat for the consideration of the 9th Ministerial Conference tentatively scheduled in October 2010.
