Strategic Framework

Main elements:

- Connectivity, enabling business enterprises to access regional and global markets and to participate in international production networks;
- Consensus and deal-making, through knowledge and capacity-building activities and multilateral institutions as third-party facilitators;
- Strategic direction by the participating countries, in partnership with the multilateral partners;
- Broadening and deepening the CAREC Program while maintaining focus on transport, trade and energy;
- New approaches in regional cooperation, including economic corridors and integrated transport/trade/ transit initiatives.



Guiding Principles

Business sector focus Pragmatic, results-based program Two-plus principle (clusters of countries)/country ownership Consensus-based, win-win outcomes Mainstreaming of regional cooperation (CAREC Governs/MIs) Strategic partnerships (SCO, EurasEC) Central Asia as a land link (Eurasia) and South Asia)

CAREC Goals

Goals achievable through the CAREC Program:

- Increased understanding of benefits of regional cooperation
- Greater commitment by participants to regional cooperation/integration
- Improved access for business enterprises to internal and external markets
- Improved business climate for investment and development opportunities
- Improved development, management and sharing of region's natural resources
- Improved cooperation in addressing shared concerns/needs



CAREC Objectives

- Trade barriers and impediments greatly reduced
- Efficient multi-modal transport systems networking the region
- Integrated electricity markets, enabling universal electricity coverage
- Best-use development of the region's resource potential, in partnership with the private sector
- Promotion of CAREC region and participating countries
- Regional cooperation in meeting shared concerns/needs
- Mainstreaming of regional cooperation (countries/MIs) reflecting business needs and priorities



CAREC Outputs

- Greater effectiveness in regional cooperation initiatives
- Constraints on shipping goods (cost/time/ facilities) to markets sharply reduced
- Increased integration of CAREC enterprises with international product markets
- Universal energy security and efficient energy trade arrangements
- A common trade framework, consistent with WTO
- Capacity for regional cooperation strengthened
- Greater coordination with other regional initiatives
- Improved recognition of CAREC region



CAREC Outcomes

- Poverty reduction and increased economic growth
- Competitiveness of CAREC enterprises strengthened
- Trade expansion, reflecting transparent, comparative-advantage principles
- New economic development options, lessening reliance on commodity trade
- Regional solutions to natural resource management issues in place of national selfsufficiency policies
- Regional public goods addressed in cooperative manner



Priority Investments/Initiatives

- Sector strategies
- Transport corridors
- Trade infrastructure
- Trade policy reforms consistent with WTO
- Business development forums/economic corridors/trade logistics
- Country-cluster grid systems, facilitating area electricity markets
- Energy efficiency initiatives
- Facilitating win-win solutions to regional issues/problems
- Knowledge and capacity-building to strengthen regional cooperation



Performance Indicators (illustrative)

- Annual public investment levels for regional projects
- Time and cost of shipping goods between major centers
- Rate of trade expansion and quality of trade (share of manufactured goods)
- Industry index: participation of CAREC business enterprises in international product markets
- Proportion of households in rural areas with 12-hour secure electricity service



Core Pillars for CAP

Reflecting views on in-country workshops, four equal pillars for CAP:

Knowledge/capacity building pillar

- Regional infrastructure networks pillar
- Trade/investment/business development pillar
- Regional public goods pillar



Sector Scope of Program

Challenge: focus on core sectors versus broadening to include new sectors/initiatives

Country views: selective broadening

MI views: maintain current focus

- Proposed compromise: two-tiered system
 - first tier: priority sectors
 - second tier: special projects
