






Highlights of CITA Consultations

- Emphasis on regional cooperation and private sector engagement
- Strong cross-sectoral linkages

Trade expansion from increased market access

- WTO accession and post-accession support

- streamlined documentary requirements and procedures

Investment Projects including Scoping Studies

- Regional improvement of border services (RIBS) projects in KGZ, MON, PAK & TAJ with components of national and/or cross-border Single Window systems
- Pilot joint customs control (JCC) including e-manifests (PRC-MON) and customs data exchange (GEO-AZE, PRC-KAZ)
- 3. Regional upgrade of SPS for Trade (RUST) projects in MON; RUST scoping for KGZ; and border SPS needs assessment in PAK & AFG
- CAREC Advanced Transit System (CATS) pilot implementation in AZE, GEO, KAZ

Policy Dialogue and Cooperation

- 1. Potential mutual recognition of SPS certificates or accreditation
- 2. Facilitated visa arrangements or special permits for traders and truck drivers, labor migrants or temporary presence of people

Results Framework

- Two-tiered approach:
 - strategic level measure and assess CITA progress using selected broad indicators to assist in formulating and prioritizing recommendations
 - operational level sector-specific associated with RSAP which could include policy matrix (theory of change), numerical targets and baselines to manage development results
- Phased monitoring (2018-2020, initial period)
- CAREC Secretariat to work closely with RTG to develop cluster or sector-specific results framework

Institutional Structure

- Regional Trade Group (RTG) as the lead and full operational authority for coordination and consultation in trade sector
- Customs Cooperation Committee (CCC) reporting to RTG, to continue on customs cooperation functions related to trade facilitation
- Working/Experts Groups in new technical areas (e.g., sanitary and phytosanitary measures, technical barriers to trade, services and investment)
- CAREC Federation of Carrier and Forwarder Associations as private sector representative to play its vital roles

Regional Trade Group Terms of Reference

Policy dialogue and strategy formulation

- inclusive and constructive forum for consensus-building, cross-learning & cooperation in trade sector
- Develop, refine and update the CITA 2030 and three-year RSAP
- Provide updates & recommendations to MC, through SOM/NFP

Project pipeline dev't, implementation & monitoring

- Oversee implementation, communications and monitoring of CITA and RSAP, prioritizing work
- Identify agreeable solutions & flexible arrangements (2+1 approach)
- Advise and support to countries, including NCTF
- Develop sector-specific monitoring framework and reporting mechanism

Institutional strengthening & stakeholders coordination

- Support establishment/strengthen NCTF or other mechanisms
- Promote evidence-based policy making and negotiations
- Enhance linkages and synergy with other CAREC sectoral bodies, private sector (Chamber of Commerce, CFCFA), CAREC Institute, global and regional mechanisms (WTO, WCO, BRI, etc)

Membership

- Appointed Representative of Country (lead agency)
- contact points and agency lists for topical issues

Meetings and Support

- Regular meetings
 - annual meeting back-to-back with SOM
 - technical meetings on an as-needed basis
- Agenda-driven and issues-based
 - determine composition of country's delegation
 - promote ownership and cross-learning
- Chairperson appointed by Host Country (rotation)
- ADB RTG Secretariat, CAREC Secretariat

Deliberations on CITA/RSAP

- General support for CITA 2030 framework and implementation approach
- Further inter-sessional work/consultations, refinement and finalization of CITA 2030 Review Paper for 17th MC endorsement
- Inputs on RSAP 2018-2020 list of investments, policy dialogue and knowledge product and services
- Willingness to cooperation and share knowledge and experience



Deliberations on RTG Organization

- General agreement on functions and tasks of the RTG
- Provision for Review of the RTG TOR (by 2024, 2030)
- Designation of Appointed Representative of the Country (ARC)
- Co-chairmanship from DP or other country lead
- Enhanced role of WTO and CAREC Institute
- Proposals for participation of CAREC chambers of commerce and CFCFA
- Plans and timing of next meeting
