



CAREC Trade: Achievements

GDP growth



4.67% (2018)

Trade snapshot*



71% total trade/GDP



4.7% net FDI inflows/GDP



31% manufactures/ merchandise exports



18% services trade/GDP

*Data excludes PRC. Trade data as of 2017 or later

- GDP (excl PRC) grew steadily to 4.67% in 2018 from 4.52% in 2017, 3.36% in 2016, and 3.43% in 2015.
- Trade in goods and services rose from 68% to 71% of GDP (2015-2017). Exports alone increased from about 27.6% to 30% of GDP (2015-2017).
- Manufactures exports grew as a proportion of total merchandise exports from 28% to 31% (2015-2017).
- Agriculture, forestry, and fishing contributed 15% value added to GDP in 2017.
- Services trade grew slightly from 17% to 18% of GDP (2015-2017), with tourism constituting 13% of total exports receipts.
- Foreign direct Investments inflows continued, at 4.7% of GDP.



- CAREC share in global trade has been small, at 0.7% from 2015-2017.
- Export growth of goods and services has widely fluctuated from 29% (2010-2011), -6% (2012-2013), -21% (2014-2015), to 16% (2016-2017).
- Export products and markets lack diversification; vulnerable to volatile oil prices.
- Unlocking agriculture's potential requires an increase in value-adding activities, farm restructuring, better logistics, improved quality of agri-food products.
- Worker remittances will be vulnerable to economic slowdown in host countries.
- To attract more FDI, good regional infrastructure, facilitated cross-border movement, harmonized regulations, and complementary investment promotion are needed.
- GDP growth will be affected by trade conflicts, growing protectionism, recession.

- RTG acts as coordinating and consultative body for trade sector in CAREC Program, specifically CAREC Integrated Trade Agenda (CITA) 2030 and its Rolling Strategic Action Plan (RSAP).
 - Sanitary and Phytosanitary (SPS) Regional Working Group (RWG)



Customs Cooperation Committee (CCC)

- cCC is the responsible body for all customs-related issues and priority areas of customs development, technology and services.
 - CAREC Federation of Carrier and Forwarder Associations (CFCFA)

Investment projects supported by ADB:

• Since 2013, \$336 million for 5 investments (loans and grants) to address both hard and soft trade-related border infrastructure needs.

Regional technical assistance by ADB:

- Since 2014, \$5.65 million for 4 regional TA projects.
- \$2.2 million (2 TAs) for approval in 2019.

• SPS National Working Groups at various stages of developing their national SPS Strategy (5-year plan) and Priority Action Plan (3-year plan).




Deliverables for 18th CAREC Ministerial Conference (2)

- Signing of CATS/ICE Agreement between Azerbaijan, Georgia, and Kazakhstan
 - Signing and launch of the pilot project (Oct and Dec 2019), which is consistent with the European Union's Common Transit Procedure and the New Computerized Transit System, making transit trade faster and less expensive along CAREC Corridor 2, and linking Asia and European markets more closely.
- Implementation of the WTO Trade Facilitation Agreement
 - Inter-subregional knowledge- and experience-sharing forum on TFA with the South Asia Subregional Economic Cooperation Program, to increase best practice and innovation in customs reform and modernization.
