Context

- Endorsement of CAREC 2030 Strategy at 16th CAREC
 Ministerial Conference (MC) in Oct 2017
- CAREC Integrated Trade Agenda (CITA) 2030 as key deliverable for 17th MC in Nov 2018
- 2017-2018 as a transition period consolidating trade policy and trade facilitation work
 - end of TPSAP 2013-2017
 - continuing CAREC trade work
 - series of consultations for CITA 2030 and RSAP 2018-2020
 - Inaugural meeting of Regional Trade Group (RTG)

Inaugural Meeting of the RTG Meeting

25-26 Jun 2018, Bangkok

- Deliberated on the CITA 2030 and RSAP 2018-2020
- Deliberated on RTG Terms of Reference
- Discussed CITA results-framework
- Discussed key developments on trade sector
 - Information sessions on CCC, WTO TFA, paperless trade, CAST, private sector role (CFCFA)
- Agreed on the trade sector deliverables for the 17th Ministerial Conference through SOM

Trade Policy Reforms

- Uneven progress among CAREC members in measures eliminating non-tariff barriers & enabling public-private dialogue; little headway in deepening trade in services & expanding labor mobility*
- Pre- and Post-WTO accession work
 - Accessions in the pipeline: UZB, AZE, TKM (observer status)
 - Trade Policy Reviews scheduled: KAZ, TAJ

Customs Cooperation

- CAREC Advanced Transit System (CATS) and Information Communications Exchange (ICE)
 - Pilot-testing (AZE, GEO, KAZ) endorsed by CCC in 2017*
 - Draft Trilateral Agreement being finalized
 - Roundtable with insurance companies in Apr 2018
- Customs ICT development
 - Supported UZB in review of customs automation and single window (2018)
- Joint Customs Control
 - PRC-MON Unified Cargo Manifest replicated in other BCPs; e-manifest underway
 - Potential JCC between AZE-GEO, PRC-KAZ JCC
- Risk Management
 - Study visit for MON in PRC on combatting smuggling (2017)

Regional Improvement of Border Services (RIBS)

- KGZ (Karamyk BCP) civil works for completion in 2018;
 Single Window Information System (SWIS) being developed
- PAK (Torkham, Chaman, Wagha BCPs) design ongoing, civil works to commence in 2018
- TAJ (Guliston BCP) procurement for SWIS in 2018
- MON (Altanbulag, ZamynUud, Bichigt BCPs) civil works under procurement. Additional financing for Borshoo BCP being processed for 2019
- Scoping study completed in UZB (and TKM) in 2017
- Potential RIBS for AZE and GEO in Red Bridge BCP

Implementation of WTO Trade Facilitation Agreement (TFA)

- CCC work reinforces TFA which entered into force in Feb 2017
- Regional workshop in Dec 2017 discussed countries' readiness and needs to implement TFA
 - 8 CAREC countries are WTO members
 - Varying degrees of consistency with TFA, even non-WTO members have aligned
 - NCTFs established, different lead agencies, composition
- Technical assistance common focus on transit,
 AEOs, advance ruling, customs valuation

Common Agenda for Modernization of SPS Measures for Trade (CAST)

- Regional TA to support CAST approved in Feb 2018
 - Components: (a) establish regional and national working groups,
 (b) align regulations with international standards, (c) improve capacity for modern border SPS control
 - Kick-off workshop in May 2018 prioritized (i) regional actions in food safety, animal and plant health, and (ii) drafted country workplans including to establish SPS working groups

Food Safety TAs

- TA for TKM (completed in 2017): aligned regulations, developed implementation guides for HACCP, training on Codex guidelines
- Regional TA to strengthen international food safety standards in agricultural value chains, including possible food safety network

Regional Upgrades of SPS Measures for Trade (RUST)

MON

- Construction/rehabilitation of labs and animal inspection areas at BCPs at technical proposal stage; TORs for supplier of diagnostic equipment prepared
- SPS inspection management system with risk-based inspection being developed
- ISO assessment of labs was conducted, for eventual international accreditation of lab tests
- RUST scoping for KGZ
 - Needs, priority actions, and investment areas identified (2017), lab visits in Bishkek (May 2018)

Cross-Border Economic Zone (CBEZ)

- Multi-tranche Financing Facility (MFF)
 - Xinjiang Regional Cooperation and Integration (RCI) Promotion Investment Program – to develop CBEZs at borders between Xinjiang (PRC), KAZ and MON
 - Inner Mongolia (IMAR) RCI Promotion Investment Program to strengthen cooperation with IMAR neighboring countries on connectivity and cross-border trade including CBEZ development with MON

MON CBEZ project

- TRTA to support masterplan development and framework for policy and project coordination with PRC CBEZ
- MON site visit to PRC-KAZ Khorgos Intl Centre of Border Cooperation (Jun 2018)
- Investment in Zamyn-Uud CBEZ planned in 2020

Trade Finance

- ADB Trade Finance Program since 2009 provides guarantees and loans to banks and SMEs
 - In 2017, supported over \$1.6 billion trade transactions in CAREC (except PRC), 75% to SMEs
 - signed agreements with new partner banks in Kazakhstan and Uzbekistan
 - conference for trade finance professionals from 50 banks in Central Asia and MON
- ADB Supply Chain Finance Program is being expanded to cover CAREC countries
- Proposed Multilateral/Regional Trade Credit and Investment Guarantee Agency to include CAREC countries

Collaboration with the Private Sector

CAREC Federation of Carrier and Forwarder Associations (CFCFA)

- active partner, regularly meets with CCC
- supported by FIATA expert, finalized standards on liability insurance, logistics equipment, container consolidation, contract and trading conditions
- completed drafting XML-based transport message standards in partnership with CNIS
- agreed to launch a research institute for regional standardization
- CFCFA members from PRC, KGZ and UZB to pilot the Andijan-Osh-Irkeshtam-Kashgar int'l transport corridor

Corridor Performance Measurement and Monitoring (CPMM)

Modest reductions in border clearance and road transport costs along the CAREC corridors

- Establishment of Regional Trade Group, CCC to continue work in customs priority areas
- Implementation of the CAREC CAST SPS working groups, sectoral priority actions and country workplans
- Inter-subregional Forum on Enhanced
 Implementation of WTO TFA (Q4 2018, Bangkok)
- CPMM 2017 Report and supplementary data collection of behind-the-border indicators

- Follow-up on investment projects (RIBS, RUST, CBEZ)
- Support for CAST Implementation
 - Establishment of Regional SPS Working Group and establish/strengthen national SPS Working Groups

- Pilot-testing of CATS and ICE
 - scale-up to other members
 - potentially engage EAEU to resolve technical issues
