 is a domestic legal entity included in the Register of Authorized Economic Operators and entitled to enjoy the special simplifications in customs clearance;



On introduction of the Authorized Economic Operator institute (Reliable Participant of Foreign Economic Activity)

The following terms are included in new Chapter 8¹ to introduce the concept of an "Authorized Economic Operator":





IN TERNAL. This information is accessible to ADB Management and staff. It may be shared outside ADB with appropriate permission.



Prioritizing operations related to the movement of goods and vehicles across the customs border of the Republic.

The following special simplifications shall be granted to authorized economic operators in the course of customs clearance

Prioritizing customs control in the form of customs examination or customs inspection

Temporary storage of goods in the AEO's warehouses, open areas and other territories

Release of goods prior to the submission of a customs declaration

Performing customs operations related to clearance of goods in the AEO's buildings, open spaces and other territories

No need to fulfill the obligation to pay customs duties and taxes when placing goods under customs procedures for internal customs transit and when releasing the goods, in respect of which the AEO acts as the declarant



Internal regulatory legal acts

In order to implement part 2 of Article 681, paragraph 2 of the Customs Code of the Republic of Tajikistan



Customs Service Order No. 94-f dated 21 July 2020 "On Approval of the Form and Execution, Cancellation, Revocation and Suspension of the Certificate of Inclusion in the Register of Authorized Economic Regulatory Bodies" was approved.

Conditions for inclusion in the Register of Authorized Economic Operators

To be included in the Register and obtain the authorized economic operator status, an interested person shall file an application with the Customs Service in the prescribed form.

Availability of a system of goods accounting, with the possibility to compare the data submitted to the customs authorities during customs clearance of goods with the data of economic operations in accordance with the requirements established by the Republic of Tajikistan legislation.

availability of assets to fulfill the obligation to secure customs payments;

carrying out foreign trade activities for at least three years

absence of outstanding obligations on customs payments

absence of cases of bringing to administrative responsibility during the previous year;
