IMPLEMENTATION OF THE TRADE FACILITATION AGREEMENT

To harmonize the customs legislation, consultations and discussions are underway on
ministry and agency platforms with legislative initiatives with the involvement of the
business community and customs-related entities. A Coordinating council is working in
the customs agencies.



According to articles 41-44 of the Customs code of the Republic of Tajikistan,
a special procedure is envisaged to make the preliminary decision on the classification
and origin



According to Chapter 7 of the Customs code a procedure is envisaged
to appeal decisions, actions (or the lack of such) of the customs authorities and their
officials

IMPLEMENTATION OF THE TRADE FACILITATION AGREEMENT



Customs payments and duties are envisaged in Chapter III of the Customs code:

- in 2018 a new customs tariff came into effect within the framework of WHO commitments;
- in 2019 a special customs payment was introduced in the Customs code of the Republic of Tajikistan;
- an export customs duty and an excise tax are envisaged for some types of goods in ad valorem, specific and combines rates;
- VAT is 18 per cent;
- customs duties are paid from the customs value of goods and vehicles.



In May 2019 the Customs authorities developed a procedure for contract signing with credit organizations on the provision of electronic payment services for customs payments


Risk management system



RISK ASSESSMENT CYCLE



The risk review and assessment consists of a continuous cycle of risk identification, analysis, assessment, profiling, targeting, mitigation and feedback evaluation.

Risk management system



INTEGRAL MODULES OF THE RMS SUBSYSTEM

Tactical risk management module:

- 1) Customs formalities and control,
- 2) Operational risk management.



Strategic risk management module:

- 1) Strategic risk management,
- 2) Risk assessment server.

Customs control cases:

- 1) Risk profile management,
- 2) Risk assessment and control during customs formalities,
- 3) Post-entry control,

IMPLEMENTATION OF THE TRADE FACILITATION AGREEMENT



In 2017 Tajikistan successfully conducted a goods time release study.



The data resulting from the study was published on the official website of the Customs service under the Government of the Republic of Tajikistan in PDF format

At the legislative level, a draft Law on changes to the Customs code was submitted to the Government of the Republic of Tajikistan in relation to the institute of the Authorized economic operators



In accordance with article 67 of the Customs code vis-a-vis the importation of perishable goods to the customs territory of the Republic of Tajikistan, and their exportation from it, the customs clearance is to take place in a simplified and priority manner.



IMPLEMENTATION OF THE TRADE FACILITATION AGREEMENT



At present there are agreements between the Republic of Tajikistan and the Russian Federation, as well as between the Republic of Tajikistan and the Republic of Uzbekistan on the simplification of the customs clearance procedures for goods and vehicles (simplified customs corridor). Also, within the framework of the Minutes of the meeting between the Republic of Tajikistan and the People's Republic of China (Xinjiang-Uigur Autonomous Region), a “greed corridor” is in place for the transportation of agricultural products over the customs border of the countries.
