


## WHERE WE WORK

### SPS AND TRADE

- Trade is important for food security and economic development
  - Access to inputs for production and quality affordable food
  - Efficient movement of commodities to market-places is essential
    - Maintaining quality
    - Developing economies are generally highly reliant on agricultural exports
    - Agricultural production often contributes to a large proportion of incomes
  - Inefficient movement of commodities affects prices, reduces quality and contributes to economic shocks





### SPS MEASURES ARE IMPORTANT

- Transmission and spread of hazards have impacts on
  - Agricultural production
  - The environment and
  - Food value chains
  - Affect the health of consumers
- Global agricultural and food supply chains facilitate cross-border spread of hazards
- Society values protection from harm
- SPS measures are intended to reduce spread of hazards

Invasive insects cost a minimum of US\$70.0 billion per year globally (Bradshaw et. al, 2016)


Unsafe food causes 600 million cases of foodborne illness and 420 000 deaths annually (WHO, 2023)



## TRADE FACILITATION

- Experience shows that the time/costs of processing of documents far outweighs other border activities
- Customs and other border interventions add to time and costs of trade

 Trade facilitation covers the full spectrum of border processes and procedures





#### IN THE SPS CONTEXT WHY IS TRADE FACILITATION IMPORTANT?



Since 1995 SPS measures have increased more than 5-fold



In themselves NTMs/SPS measures are not necessarily barriers to trade.



Often procedures and processes of NTMs that are the barriers




### IMPLEMENTING EPHYTO

- Driver of improvements in efficiency of trade and security of information
  - Expedite and increase effectiveness of government and trade processes
  - Remove the time and costs of manual processing of documents
  - Reduce fraudulent
    certificates
  - Increase importing country confidence in compliance
- Data and information for more effective risk management
  - Opportunity to undertake
    pre-arrival screening
  - Pre-plan interventions
  - Sharing of information between border agency to facilitate clearance processes



#### IMPLEMENTING EPHYTO – HOW WE WORK

- Coordinated approach aligned with TFA and whole of government objectives
  - Opportunity to leverage TFA initiatives to support NPPO
  - Ensure coordination with other government initiatives on digitization
  - Facilitate coordination between public and private sector objectives
- Business process analysis and reengineering
  - Focus on a whole of trade assessment
  - Analysis of all trade components to identify how/where/when NPPO documentary processes affect border processes



#### IMPLEMENTING EPHYTO – HOW WE WORK

- Analysis of mechanisms for exchange
  - NSWs
  - Existing or proposed business management systems
  - GeNS
  - Transition between options
- Support to change management and training of staff and traders
- Coordination with other national automation/digitization initiatives
- Support through technical and financial assistances when coordinated with WB financial operations
  - Analysis of implementation gaps and how best to address them (equipment, access to support services, etc.)



### PROJECTS



#### Completed

- Nepal, Cote D'Ivoire
- NSW connection to the hub
- Some back-office automation included in NSW development
- Cote D'Ivoire since March 2023
  - 1,787 import ePhytos received from 9 countries
  - 9,544 export certificates to 41 countries.

#### Underway

- Burkina Faso BPA analysis completed, NSW connection proposed
- Zambia Implementation as part of Government management system
- Fiji connecting GeNS to ASYCUDA to simplify clearances and improve information transfer
- Bangladesh Analysis of existing system for connection to IPPC hub
- Malawi/Mozambique Part of larger lending operation. Support to development of business management systems.
